NOTICE TO THE MAKING OF A COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 (AS SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT, 1966 AS AMENDED) AND AMENDED AND EXTENDED BY SECTION 6 AND THE SECOND SCHEDULE OF THE ROADS ACTS, 1993-2015, THE PLANNING AND DEVELOPMENT ACTS, 2000-2019, THE HOUSING ACTS, 1966-2015, THE LOCAL GOVERNMENT ACTS, 1925-2019, THE ROADS ACTS, 1993-2015 AND ALL OTHER ACTS THEREBY ENABLING.

The Clare County Council (hereinafter referred to as "the Local Authority") in exercise of the powers conferred upon it by section 76 of the Housing Act, 1966 and the Third Schedule thereto, as extended by section 10 of the Local Government (No. 2) Act, 1960 (as substituted by section 86 of the Housing Act, 1966 as amended) and as amended and extended by section 6 of and the Second Schedule to the Roads Acts, 1993-2015, the Planning and Development Acts, 2000-2019, has made an order entitled as above which is about to be submitted to An Bord Pleanála (hereinafter referred to as "the Board") for confirmation.

If confirmed, the order will authorise the Local Authority to permanently acquire compulsorily the land described in the First Schedule hereto, and to extinguish the public and private rights of way described in the Second Schedule hereto for the purposes of providing the following: Development of an Inner Relief Road in Ennistymon including a new vehicular bridge crossing of the Inagh/Cullenagh river approximately 80 metres upstream of the existing bridge crossing. The overall route runs from a point located approximately 170 metres south east of Blake's Corner on the N85 national road to a point located approximately 180 metres west of Blake's Corner on the N67 national road, via Bogbere Street. The development includes the pedestrianisation of the existing bridge, the inclusion of a roundabout at the western end of the proposed new bridge crossing on the L-1084 and the relocation of the existing public car park adjacent to New Road (N85) and all associated site works through the townlands of Deerpark West, Ardnacullia North and Ennistymon in the County of Clare. Owners, lessees and occupiers of the land described in the First Schedule and of the private right of way to be extinguished described in Part II of the Second Schedule hereto will receive individual written notice. Any objections to the compulsory acquisition of land and to the extinguishment of the said right of way should be made in writing to An Bord Pleanála, 64 Marlborough Street, Dublin 1, D01 V902 before 5.30pm on Friday 18th September 2020.

The order will also authorise the Local Authority to extinguish the public rights of way described in Part I of the Second Schedule hereto, by order made by the Local Authority after the Local Authority has acquired the land, where the said rights of way are over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof. Any objections to the extinguishing of the said rights of way should be made in writing to An Bord Pleanála, 64 Marlborough Street, Dublin 1, D01 V902 before 5.30pm on Friday 18th September 2020.

e Board cannot confirm-

(a) a compulsory purchase order in respect of the land if an objection is made in respect of the acquisition by an owner, lessee or occupier of the land, and not withdrawn,

(b) the extinguishment of a private right of way or an order which authorises the extinguishment of a public right of way if there is an objection to the extinguishment, which is not withdrawn.

until it has caused to be held an oral hearing into the matter and until it has considered the objection and the report of the person who held the oral hearing. However, regard should be had to the provisions of section 218 of the Planning and Development Act, 2000 (as amended) which provide that where as a result of the transfer of functions under section 214, 215, 215A, 215B or 215C of the Planning and Development Act, 2000 (as amended), the Board would otherwise be required to hold a local inquiry, public local inquiry or oral hearing, that requirement shall not apply to the Board, but the Board may, at its absolute discretion, hold an oral hearing in relation to the matter, the subject of the function transferred.

An Environmental Impact Assessment (EIA) screening process was carried out for the project, and Clare County Council has determined that the project would not have a significant effect on the environment, and that an EIA is not required.




