The site is located in the settlement of Ennis and is zoned as "Existing Residential" as per the Clare County Development Plan 2017-2023 (as varied). It accommodates a detached bungalow within the Woodview housing estate, which is located off the Shanaway Road. Houses in this development are primarily detached bungalows, of varying designs. More recently dwelling of a story and a half natures have been constructed. The site is bound to the front by a low block wall. Side boundaries consists of mature shrubbery.

Background to Referral

This Referral under Section 5(3)(a) of the Planning and Development Act 2000 (as amended) has been made by Sara Carson Smith. The applicant's legal interest in the site is stated as owner of the property.

The applicant is seeking a Section 5 Declaration as to whether the demolition of the front extension and replacement of windows at No. 4 Woodview, Ennis, County Clare is or is not development and is or is not exempted development.

Statutory Provisions

Planning and Development Act, 2000 (as amended)

In order to assess this proposal, regard has to be had to the *Planning and Development Act 2000, as amended*.

S.3.(1)In this Act, "development" means, except where the context otherwise requires, the carrying out of any works on, in, over or under land or the making of any material change in the use of any structures or other land.

'Works' are defined in Section 2 of the Planning and Development Act 2000, as amended as follows:

"works" includes any act or operation of construction, excavation, demolition, extension, alteration, repair or renewal and, in relation to a protected structure or proposed protected structure, includes any act or operation involving the application or removal of plaster, paint, wallpaper, tiles or other material to or from the surfaces of the interior or exterior of a structure.

Exempted Development

- 4.—(1) The following shall be exempted developments for the purposes of this Act—
- (h) development consisting of the carrying out of works for the maintenance, improvement or other alteration of any structure, being works which affect only the interior of the structure or which do not materially affect the external appearance of the structure so as to render the appearance inconsistent with the character of the structure or of neighbouring structures;

Planning & Development Regulations, 2001, as amended

Article 6 refers to Exempted Development and states that subject to Article 9, development of a class specified in column 1 of Part 3 of Schedule 2 shall be exempted development for the purposes of the Act, provided that such development complies with the conditions and limitations specified in column 2 of the said Part 3 opposite the mention of that class in the said column 1.

Planning and Development Regulations 2001 (as amended) Schedule 2, Part 1, Class 50

(a)The demolition of a building, or buildings, within the curtilage of—(i)a house, (ii)an industrial building, (iii)a business premises, or (iv)a farmyard complex.

(b) The demolition of part of a habitable house in connection with the provision of an extension or porch in accordance with Class 1 or 7, respectively, of this Part of this Schedule or in accordance with a permission for an extension or porch under the Act.

Condition s and Limitations

- 1. No such building or buildings shall abut on another building in separate ownership.
- 2. The cumulative floor area of any such building, or buildings, shall not exceed:
 - a. in the case of a building, or buildings within the curtilage of a house, 40 square metres, and
 - b. in all other cases, 100 square metres.
- 3. No such demolition shall be carried out to facilitate development of any class prescribed for the purposes of section 176 of the Act.

Under Article 9 (1) of the same Regulations, development to which Article 6 relates shall not be exempted development for the purposes of the Act:

(a) if the carrying out of such development would –

- (i) contravene a condition attached to a permission under the Act or be inconsistent with any use specified in a permission under the Act
- (ii) consist of or compromise the formation, laying out or material widening of a means of access to a public road the surfaced carriageway of which exceeds 4 metres in width,
- (iii) endanger public safety by reason of traffic hazard or obstruction of road users,
- (iv) interfere with the character of a landscape, or a view or prospect of special amenity value or special interest, the preservation of which is an objective of a development plan for the area in which the development is proposed or, pending the variation of a development plan or the making of a new development plan, in the draft variation of the development plan or the draft development plan.
- (vii) consist of or comprise the excavation, alteration or demolition (other than peat extraction) of places, caves, sites, features or other objects of archaeological, geological, historical, scientific or ecological interest, the preservation, conservation or protection of which is an objective of a development plan or local area plan for the area in which the development is proposed or, pending the variation of a development plan or local area plan, or the making of a new development plan or local area plan, in the draft variation of the development plan or the local area plan or the draft development plan or draft local area plan,

- (ix) consist of the demolition or such alteration of a building or other structure as would preclude or restrict the continuance of an existing use of a building or other structure where it is an objective of the planning authority to ensure that the building or other structure would remain available for such use and such objective has been specified in a development plan for the area or, pending the variation of a development plan or the making of a new development plan, in the draft variation of the development plan or the draft development plan,
- (x) consist of the fencing or enclosure of any land habitually open to or used by the public during the 10 years preceding such fencing or enclosure for recreational purposes or as a means of access to any seashore, mountain, lakeshore, riverbank or other place of natural beauty or recreational utility,
- (xi) obstruct any public right of way,
- (xii) further to the provisions of section 82 of the Act, consist of or comprise the carrying out of works to the exterior of a structure, where the structure concerned is located within an architectural conservation area or an area specified as an architectural conservation area in a

development plan for the area or, pending the variation of a development plan or the making of a new development plan, in the draft variation of the development plan or the draft development plan and the development would materially affect the character of the area.

Having regard to the nature of the proposed work, which it is noted will affect the exterior of the dwelling, I do not consider same will materially affect the external appearance of the structure so as to render it inconsistent with the character of the structure / neighbouring structures. It is noted from the submitted documentation that the subject porch was a more recent addition to the original house. The removal of same is required for reasons to do with the structural integrity of the dwelling. The porch will be replaced with a wall and window identical to the adjacent window. I am satisfied that such works may be considered under the exemptions as set out under Section 4(1)(h) of the Act.

The subject porch is located to the front of the existing dwelling and is the same ownership of the principle dwelling.

2. 2. The cumulative floor area of any such building, or buildings, shall not exceed: (a)in the case of a building, or buildings within the curtilage of a house, 40 square metres, and (b)in all other cases, 100 square metres.

The cumulative floor area of the porch to be demolished does not exceed 40 sqm.

3. No such demolition shall be carried out to facilitate development of any class prescribed for the purposes of section 176 of the Act.

The proposed demolition is not to facilitate development of any class prescribed for the purposes of section 176 of the Act.

Existing Site Layout Plan




