



Proposed red coloured tactile paving (400x400mm slabs). Existing footpath to be broken out to facilitate construction of dropped crossing as per CC-SCD-05134

Cast in sockets for bollards to be set in concrete. Bollards to be set-out at 2.5m c/c

New edge of carriage way road marking (RRM025) to start from this location and taper out with hatch marking as per Figure 7.19 and Table 7.5 of the Traffic signs Manual

Existing line marking along road edge for the extent of the scheme to burn off

4.8x2.4 Disabled parking bay with 1.2m wide free zone to sides and rear, to be lined and painted as per Traffic Signs Manual

Bevelled kerb to maintain access to the church as per tii cc scd 05141 and define parking extents

New concrete kerb to be laid as per CC-SCD-01101 TYPE A. Tapered kerbs at start and end with full height in between. Section of 2 m wide concrete 100mm deep to be poured. Brushed surface with bull nosed edge finishes.

Erect Pedestrians Sign W140 on approach to Ogonnelloe

Solar driver feedback sign to be located north of existing entrances for oncoming drivers with associated duct chamber

2m wide concrete footpath parallel to church boundary wall

9 No. Parking Spaces with Line Marking

Existing Public Light

Road gully to tie into existing drainage network required to take away stormwater runoff

Min 9m of Kassel kerbing laid for bus stop. Apply Line Marking for online Bus Stop cage 12m long. Bus Stop sign to be erected, supplied by NTA

Flush Kerb to allow for wheelchair access

Proposed uncontrolled crossing with buff coloured tactile paving at both sides (as per cc scd 05136).

Proposed new Public Light

Warning tactile paving for transition from active travel scheme to local trail. ladder tactile to be used.

New edge of carriage way road marking (RRM025) to start from this location and taper out with hatch marking as per Figure 7.19 and Table 7.5 of the Traffic signs Manual
