#### Not Around Us



On the 1st January Tulla FC became a smoke free club, showing their commitment 'to reducing the use of tobacco smoking due to its proven harmful health effects by adopting a Smoke Free Policy (including Electronic Cigarettes/Vaping) at Tulla United AFC Grounds in The Cragg. The aim is to protect the health of all individuals involved with the club as well as visitors to the grounds by keeping them safe from all smoke related harm.' They were provided with Not Around Us Signs from Healthy Clare. It is hoped that more clubs will follow the example set by Tulla FC during 2025.

#### **Free Period Poverty Initiative**



Healthy Clare has completed 2024 reporting on the Department of Health Period Poverty Programme. An application has been made to the Department of Health to secure a further €15,000 to continue the scheme into 2025. In 2024, over 1,100 packets of products were distributed.

#### De Valera Library programme of events

The programming of events and activities in the new DeValera Library has commenced for 2025 with the first of 3 workshops called "Outspoken" aimed at LGBTQIA+ people in Clare and people who have migrated to live in Clare from other countries and was hosted in the library by renowned poet Sarah Clancy. This free event invited community members to explore their creativity in 2025 in collaboration with the Ennis Book Club Festival. The library was also delighted to host the launch and exhibition of a captivating series of photographs showcasing portrait images of LGBTQ+ community members from across the county. The portraits were all captured during Clare's Pride celebrations with the aim of increasing visibility and understanding from the community. The exhibition was supported by the Department of Children, Equality, Disability, Integration and Youth and the photographer was Debbie Hickey.

Young parents and their babies/toddlers can now avail of the "My Baby and Me/Hug your book" 13 week course in association with the LCETB. This free course aims to help parents who want to make reading fun and learn new ways to support their children's literacy

skills through fun and rewarding activities. It will also help to support children's language and literacy development as well as social and emotional needs. Week 1 of the Irish Language comic book club got off to a great start with 12 children working in Irish, learning all about different comic book styles, drawing techniques and developing storylines to produce their own mini comic book. Participants will then work together to create a web comic containing the comic strips and a visual dictionary, which will be uploaded to the Clare Libraries website and shared with Foras na Gaeilge.

#### Right to Read/ Adult Literacy for Life

The Clare Libraries "Right to Read Action" Plan 2025 was submitted, detailing all collaborative activities planned for promoting literacy by the Literacy network for the coming year.

#### **Local Studies**



Local Studies Centre has received 50 books, part of the personal collection of Paddy Hogan, Clare TD, Playwright, Barrister, Cathaoirleach of Dáil Éireann, donated by Senan Hogan. Another archival collection has been added to the Local Studies holdings.

Local Studies hosted an exhibition and talk by Cumann Merriman on Brian Merriman and the Ennis Court of Poetry on Saturday the 25th. Several contemporary manuscripts will be on display and a manuscript transcribed by Mícheál MacConsaidín in 1818 has been scanned. Mícheál MacConsaidín was also known for his wide knowledge of Irish and as a first-class scribe. He copied in neat lettering a complete replica of "Cúirt an Mhean Óiche" and Sean O'Conaills "Tuireamh na hÉireann". He is also credited with having written down much Ossianic verse, several local poems, and romantic tales from the old Irish. This digital document is available for consultation in the Local Studies Centre.

The Local Studies Librarian gave an outreach talk to St Caimin's Secondary School in Shannon as part of their History Week. Work is ongoing on upgrading the Local Studies Website.

#### **Clare Archives**

Refurbishment works in the Archives section in Beechpark are nearly completed. The works included internal upgrades and new shelving. In January, there were the usual archival queries and there were also overseas researchers using Clare Archives. The audit of the external hard-drives is complete and the backup of hard-drives will commence.

#### **Clare Arts Office**

A total of 473 people visited the new art gallery Súil in January. Cultúrlann Sweeney, Kilkee hosted two films and three panto performances, a wildlife talk and a yoga retreat. Three radio interviews

took place on Clare FM and one on Scariff Bay Radio. Two artist clinics took place in advance of the Arts Grants and Short Film Scheme. One artist's webinar with clinics for artists also took place online.

The Arts Office continued to assist the locations manager of '2 Kids walk into a Bank' starring Liam Neeson with locations in East Clare as well as a cookery / food programme in Ballycuggeran. The Arts in

the Community programme continued in St. Joseph's Hospital, Ennis and in Raheen Hospital. Consultations with organisations in Shannon continued as part of the "Creative Places" research programme and three groups of Clare Youth Theatre continued to meet weekly.

Two artists residencies began – one in Shannon and one in Toonagh whilst the first "Arts and Disability" project began with Ennis Voices for Autism.

### KILLALOE MD

#### Elected Members of Killaloe MD agree New Strategic Plan for Killaloe MD 2024-2029

Enhancing the delivery of services at a local level and supporting the communities, towns and villages of East Clare as places to live, work and recreate are some of the objectives set out in a new Strategy and Workplan by the Elected Members of Killaloe Municipal District.

The 'Elected Members of Killaloe Municipal District – Strategy & Work Plan' is a new strategy and work programme for the future planning, growth and development of East Clare with a specific focus on regenerating towns and villages and supporting the growth of tourism in the area and strengthening local democracy. The strategy, which follows the success of the previous Strategy

was adopted by the Elected Members at the January meeting of Killaloe MD and sets out to further align local Killaloe MD level priorities and strategic objectives with new national and county policies. This strategy sets out a shared vision between the Elected Members and staff of Killaloe Municipal District, setting out strategic objectives and priorities for East Clare and the supporting projects and mechanisms required for implementing and achieving those objectives.

"This new plan has responded to updated national policies and guidelines. Strengthening local democracy and the enhancement of services delivered to the people at Municipal District level is a key consideration. The strategy and work plan also reinforces the critical role that the Killaloe Municipal District Office in Scarriff and all Local Authority staff play in the planning and delivery of services at the local level for the betterment of East Clare and the county.

## Killaloe MD publishes first of its kind Socio-Economic Profile.

Killaloe Municipal District (MD) of Clare County Council published a Socio-Economic Profile in January one of the first of its kind in the country. The independent report undertaken by People and Place consultants on behalf of Killaloe MD, offers a comprehensive overview of the district and draws from the latest data available from the Central Statistics Office (CSO) Census 2022 and a range of other authoritative datasets. It provides a detailed analysis of the district's demographic, economic, and social characteristics.

Launched at the January MD Meeting, The purpose of this document is to provide a solid evidence base to support future decision-making within the Killaloe MD. It is designed to serve a diverse audience, including elected members, local community groups, businesses, students and researchers and indeed the general public, as interested parties can gain insights into the development of Killaloe MD and engage more meaningfully with their community and MD

There are many positive indicators of strong and sustainable development within the Killaloe MD with consistent growth in population, increasing levels of employment and many positive social characteristics such as high levels of education attainment, broadband access and levels of working from home.

Key statics from the report indicate that

- Population growth between 2016-2022 within the Killaloe MD was recorded at +8.8%, higher than both the county (+7.7%) and the national rate (+8.1%). Across the four MDs, only the Ennis MD had a higher growth rate at +9.8%. Over the five year period (2016-2022), the population in the MD has increased by over +1,700 persons;
- The largest settlements within the MD are Killaloe (1,666), Quin (922), Scarriff-Tuamgraney (854), Tulla (697), Kilkishen (651) and Crusheen (649);
- With 17% of the population in the County at 27,871, Killaloe MD has been growing since 1991 at a much higher rate the

both the state and the rest of the Clare. Much of this growth has been driven primarily by net migration.

Local community groups and organisations are also encouraged to utilise this profile to advocate for resources, plan community projects, and address local needs effectively, local entrepreneurs and companies able to leverage this data to understand the local market, identify opportunities for growth, and make informed investment decisions. The General Public: Residents and interested parties can gain insights into the regions development and engage more meaningfully with their community.

## Killaloe - Ballina Town Enhancement and Mobility Strategy

#### **Killaloe Courthouse**

Killaloe Courthouse, derelict and vacant for several years since its last use, has been the focus of a feasibility study led by Killaloe MD to define how best to re-use and reimagine the building and grounds. The building is a Protected Structure and its location, within the heritage town centre of Killaloe, provides a key opportunity to revitalise and reimagine the building, while also encouraging footfall and activity to this area of the town centre. The building was identified as an Opportunity Site in the Killaloe-Ballina Town Enhancement and Mobility Strategy

In January, following the receipt of Town and Village Renewal Grant funding, Hourigan Drake Architects completed a Feasibility Study on the proposed re-use of the Courthouse. The feasibility was undertaken over a number of months and included significant public consultation and engagement with Departments in the Local Authority.

The feasibility study comprised 3 main elements: 1) detailed surveys of the property 2) Property feasibility study and 3) Public realm areas to front and rear of the property



The feasibility study, together with an economic and financial appraisal, architectural history, QS report, and feasibility study identified the reuse of the Courthouse and an extension as a Cultural and musical venue. The proposed redevelopment and reuse of the Killaloe Courthouse as a Cultural Venue is grounded in an identified community need and a viable and sustainable financial model. The feasibility study concluded that supported by a strong governance structure and with the buy in from the local community from the outset, the project will clearly deliver lasting benefits to Killaloe Ballina and the wider area to justify the upfront investment and create long term economic and social return.

#### **Killaloe Bridge Opportunity Site**



The new Killaloe bypass and the new River Shannon crossing provide an exciting opportunity to reimagine the existing Killaloe Bridge. This now offers a once in a generation opportunity to change the operation and function of the bridge and as such it facilitates the full pedestrianisation of the bridge.

The analysis completed in support of the bypass predicts a 40% reduction in traffic using the existing bridge as a direct result of the bypass. The Killaloe-Ballina Plan proposes to reduce the vehicular dominance on the bridge and provide enhanced walking and cycling facilities in both towns and

Removing traffic using the bridge allows for the bridge surfacing to be updated to make it a pedestrian friendly space area and support the proposals at either end of the bridge, which focus on pedestrians and cyclists. In particular the proposed new arrangement will enhance the attractiveness so the historic bridge and viewpoints from the bridge to St. Flannan's Cathedral, Killaloe, Ballina and the River Shannon for residents and tourists. The Plan indicates that once the bypass / new bridge crossing is operational, it is proposed to implement the new arrangement for the bridge – which will be subject to detailed public consultation with the local community and key stakeholders.

Following an informal consultation event in Killaloe which was well attended (SEE PHOTO), the month of January focussed on detailed consultation with Emergency Services and a number of Key Stakeholders and traders and retailers from both communities. A formal process, including community consultation, to close the existing bridge to vehicular traffic and provide pedestrian and cycle access will commence in February under Section 38 of the Roads Act.

#### **RRDF** Application

Killaloe MD are preparing an RRDF application on behalf of Clare Co. Council and Tipperary County Council for the enhancement of the public realm and a number of town centre economic development and tourism opportunity developments. The focus in January was undertaking background economic appraisals to assist in the preparation of the funding application. In addition a number of community groups and stakeholders were met. It is anticipated that an application for RRDF Funding will be made on or before 15th March.

#### **Crusheen Mobility Plan**

Following a 2nd round of public consultation including an evening event in Crusheen, during which staff from Killaloe MD and the consultant team discussed with the local community their Ideas and Emerging Options for the Crusheen Mobility Plan, in January an on-line survey concluded. The survey sought the view of residents on a range of proposed enhancements, including proposed enhancements to footpaths and streets, and possible new pedestrian crossings, cycle paths and bus shelters. Over the last week, the results of the community wide on-line survey were collated and are being assessed with a view to ascertaining the community's preferences. It is anticipated that the views of the community will directly inform the preparation of a Draft Plan due in March.







#### **Tuamgraney Trail Head & Trail Linkage Project**

Following an Application under the Outdoor Recreation Infrastructure Scheme (ORIS) approved funding of €192,000 was received for Tuamgraney Trail Head & Trail Linkage Project. The project will provide an outdoor recreation and amenity project enabling direct walkable access from the settlements of Scarriff/ Tuamgraney to the existing 12km section of Killaloe/Lough Derg/ Ogonelloe greenway and walking trail.

The successful receipt of the funding is testament to the long standing communications of engagements between Killaloe MD and local groups, in particular Tuamgraney Development Association, advocating for its completion. The project will be undertaken by the outdoor staff of Killaloe MD and in January detailed survey work of the route was undertaken in advance of preparation of plans for consent and construction.

#### **Bodyke Public Realm and safety enhancements**

The focus of the Outdoor Staff in Killaloe in January was on the completion of Low Cost Safety Works in Bodyke – see 2 photos. The enhancement of pedestrian footpath and safety works, together with junction works in the village is part of Killaloe MD's engagement with the community regarding enhancements of the public realm in the village. January also saw the completion of survey and submission of a Part VIII application for a car-park and cycle park in the village centre of Bodyke.





#### Storm Éowyn

Over the weekend of 24th – 26th and throughout the following week, Killaloe MD outdoor workers undertook significant repair and road clearance of storm damage arising from Storm Éowyn. East Clare in particular experienced significant damage from fallen trees and the outdoor workers worked tirelessly to assist communities and residents to access roadways, homes, farms and businesses.

## STORM ÉOWYN

In the last week of January, the Social Directorate focussed its attention on the challenges brought by the high-speed winds on our communities by Storm Éowyn. The team and crews in north Clare faced some of the greatest impacts of the storm and worked with our communities, councillors and partner agencies to prepare for the storm and respond to the aftermath. This work continues across the north Clare area.

Our amenity facilities were closed during the red weather warning and on Saturday the Ennis Leisure Facility re-opened while our teams in Active Ennis assessed damage and removed fallen trees in Lees Road which re-opened on day two after the storm.

Our staff worked as part of the emergency telephone line teams and our Clerks of Works and technical teams assessed and responded to the numerous calls that came in through the emergency lines relating to our housing tenants – it is estimated that 5% of our stock has been affected.

Damage caused ranged from a small number of properties where sections of tiles were stripped by the wind to larger numbers where one or two tiles or ridge caps were dislodged. Boundary fencing has been knocked down in a number of properties and a small number of block boundary walls were also blown over.

All calls have been assigned to contractors on the Council contracting framework for resolution with the priority to make safe in the first instance, repair roof damage as the priority and lastly to address boundary walls and other damage issues.

We continue to work to record, assess and resolve all issues and acknowledge the engagement and patience of our tenants, councillors and contractors during this period.



The highest demand throughout the county remains for 1 and 2-bedroomed properties. There are 2,177 applicant households (78%) who have a requirement for this property type.

#### **Housing Allocations**

Properties in the new social housing development at Harveys Quay, Parnell Street Car Park Ennis, have been allocated and the new tenants received the keys to their new homes on 22nd January last. This development comprises 4 no 1 bedroomed apartments. This new development is centrally located and services such as education, employment and shops are all within walking distance therefore reducing reliance on cars. Furthermore, repurposing this vacant building will make the town more attractive which in turn means more benefits to our local economy.





The new social housing development at Droichead Nua, Ballyminogue Scarriff is completed, and the tenants received the keys to their new homes on 10th and 13th of January. This development comprises 16 no apartments and 2 no 3 bedroomed houses.

Clare County Council continues to work with the Approved Housing Bodies in relation to the delivery of social housing. Phase 3 of the social housing development located at Acha Bhile, Lahinch Road Ennis was recently advertised on our CBL site. This development which is being delivered by Cluid Housing and comprises 10 no 3 bedroomed houses. In excess of 200 expressions of interest were received for this development which the Allocations Team are currently assessing.



#### **Tenant Purchase Incremental Scheme**


There remains significant interest in the LA Tenant Purchase Incremental Scheme. We currently have 27 open cases at various stages of the process. The sale of seven properties under the tenant purchase scheme completed in 2024. It is expected that the sale of an additional 3 properties will be completed within the 1st quarter of 2025.

Having consulted with elected members in relation to maintaining our newer stock we have agreed that properties purchased or built since 1st January 2016 will not be available for sale under this scheme. This can be reviewed at end of current Housing Delivery Plan period in 2026. We have also agreed that 1-bedroom properties will not be available under the scheme.

#### Estate Management

The Estate Management Team continue to undertake regular routine and response calls to tenants, dealing with complaints re breaches of Tenancy and ASB as well as inspecting Local Authority tenancies and providing the necessary supports to tenants. The team were successful in securing 3 Repossession Orders in court in 2024. A number of further Repossession Applications will be going through the Courts in the coming months.

The team continue to be extremely active in carrying out tenancy visits. It should be noted that the follow up on complaints received and the no. of visits carried out do not correlate with an increase in instances of anti-social behaviour or tenancy breaches but rather that a more proactive approach is being taken with the team in engaging with tenants.


#### Private Rented inspections:

#### Local Authority Home Loan

#### Local Authority Purchase and Renovation Loan

The Local Authority Purchase and Renovation Loan was introduced on the 22 July 2024. This is a government backed mortgage and loan for the purchase and renovation of derelict and non-habitable homes. The property must be eligible for the Vacant Property Refurbishment Grant, whether derelict, nonhabitable or simply vacant.

#### **Traveller Accommodation**

The first meeting of the LTACC, since the adoption of the new Traveller Accommodation Program 2025 –2029, was held in January 2025 whereby the actions of the program will continue to be monitored and delivered upon. An additional €80k has been made available under the National Preferential Mobile Home Scheme for Travellers in 2025 which will be allocated in line with terms and conditions of the scheme to suitable applicants.

#### **The Homeless Action Team**

The level of complex cases presenting to the Homeless Action Team in Clare has continued to increase. Additional demands are being placed on the Homeless Action Team to provide Emergency Accommodation in a safe and appropriate manner. The levels of support, advice and advocacy, being requested from households around areas such as Homeless Services, Housing Requirements, Health supports, Outside Support referrals and the need for Emergency Accommodation within this region is increasing.

There has been a notable rise in the number of presentations of individuals and households experiencing difficulties and concerns around Hospital discharges, Prison releases, Family or relationship breakdown, addiction or mental health concerns, dual diagnosis, and a further increase in the number of households presenting from the Travelling Community.

The level of aggression being experienced by the Homeless Action Team staff and supporting agencies staff which increased in 2024 needs to be monitored and addressed in 2025. There has also been a level of non-engagement by service users along with refusals of Emergency Accommodation Support offers in this quarter.

Prevention and support remain a key factor in the workings of the Homeless Action Team. Several single and household presentations worked with staff around prevention options and supports which in turn prevented the need for Emergency Accommodation and avoiding entering Homeless services. Other individuals and families were supported in accessing Emergency Accommodation either within our services or through private establishments.

The Homeless Action Team continues to pursue additional emergency accommodation options at a time when accommodation is in high demand generally.

#### Homeless Services [Homeless Action Team HAT]

Clare Homeless Action team continues to engage with all necessary stakeholders, service providers and local supports to adopt a collaborative approach to the tackling of Homelessness.

#### **Affordable Housing Schemes for County Clare**

CCC continue to run Expression of Interest (EOI) Campaigns seeking proposals on options to deliver affordable homes in County Clare. CCC are also engaged with developers with potential for Part V affordable delivery.

To date CCC have received approvals for access to the Affordable Housing Fund for the following developments:

- Tulla Rd Ennis 10 units.
- Lahinch Rd Ennis 11 units
- Shannon 10 units (3 units allocated).

Properties in Shannon are currently available for applicants on our online portal and an open evening was held in Shannon last week which was very well attended by interested households. The scheme on Lahinch Road will be advertised this week with the online applications portal opening on February 27th. CCC are currently engaged with 4 other developers, that have expressed interest in affordable housing, for potential inclusion on the scheme.




On the 7th of November 2024, The Minister approved an increase in the grant cap from  $\pounds$ 420,000 to  $\pounds$ 462,000.

Applications to the scheme can be submitted on-line through our website. The website includes supporting information to further assist homeowners regarding the application process. Clare County Council DCB Team have also included a video on our website called "how to make on application" to further assist homeowners in the application process. In addition, our team are available to assist with any queries homeowners may have. Clare County Council continue to administer and validate applications since the commencement of the scheme via the online portal. Clare County Council are engaging with the Housing Agency and the DHLGH and continue to carry out all associated duties.

To date Clare County Council have issued 31 Remedial Option Grants, with the total value of  $\notin$ 9.19m awarded by the housing agency and are awaiting input from the Housing Agency to further process 91 applications with grant amounts to follow.

CCC intend to hold further information evenings in 2025 to target people with limited digital resources and/or capabilities, to assist them further in making an application and other elements of the DCB application process.

Clare County Council continue to engage with the DHLGH to ensure social houses affected by DCB are included in a similar scheme.

#### Update on capital programme:

Housing capital schemes are progressing well and are at varying stages of design and construction across the County Clare. Doonbeg and Gort Road projects are under construction and these projects are continuing to progress well. Other capital projects are expected to commence in Q1 2025.

### UKRAINIAN SERVICES TEAM

The CSO figures show there were 612 Temporary Protections granted nationally in the past month with an average of 22 granted per day, the number of new arrivals into the Country has reduced by 178 people compared to the weekly figures outlined in the previous Monthly Management Report. There are currently 5,117Ukrainian Beneficiaries of Temporary Protection (BOTP's) living in County Clare, representing a decrease of 178 people in the County compared to figures released previously. There are 1,445 people accommodated in 26 multi-occupancy facilities located throughout the County - this reflects a decrease of 107 people compared to previous figures. The remaining people are accommodated in residential settings in formal hosted arrangements through the Irish Red Cross and Clare County Council's Offer-a-Home

scheme. There is still huge interest in the scheme since it's launch in November 2022, we currently have 257 homes offered resulting in an increase of 2 properties compared to figures released previously. We currently have 2 new properties offered that will be available during the month of February. To date our Matching & Relationship Manager has facilitated the accommodation of 506 people that were originally living in hotel and multi-occupancy facilities.

The Government has confirmed the Accommodation Recognition Payment Scheme (ARP) is secure until the end of March 2025, it is anticipated we will have a better understanding of the position of this scheme in early 2025.

## LOCAL AUTHORITY INTEGRATION TEAM

The Local Authority Integration Teams (LAITs) have been set up in all local authorities. Their purpose is to help coordinate the different kinds of support available for people who are applying for international protection, refugees, and others in similar situations.

The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important services that can help them integrate into the community.

#### Who do LAITs support?

LAITs provide support for:

- Applicants for International Protection (IP)
- People who have been granted refugee status or other forms of protection, such as subsidiary protection or permission to remain
- Refugees who have been resettled in Ireland through a government programme
- Beneficiaries of Temporary Protection (BOTPs)

#### How is the support provided?

LAITs operate under the principle of 'Integration from Day One'. This means that LAITs provide integration support to people who need it as soon as they arrive in Ireland.

#### What services do LAITs provide?

The work of LAITs isn't meant to replace existing services. Instead, LAITs help connect people with the existing services that are most suitable for their needs. This includes things like:

- Being a direct contact for new arrivals, helping them with any problems they might have when dealing with public services
- Connecting new arrivals with services like legal help, childcare and healthcare
- Connecting new arrivals with services that improve their ability to live independently, like job training, English classes, education, and apprenticeships
- Guiding new arrivals through the process of applying for financial support, medical help, child benefits, and other services they might need
- Holding meetings in local areas and using community development principles to help those who attend
- Supporting people if they face racism or other unfair treatment, helping them report it to the right authorities
- Helping vulnerable new arrivals get in touch with nongovernmental organisations (NGOs) and other services if they need extra help

## How do I contact my Local Authority Integration Team?

You can contact LAIT's by email on integration@clarecoco.ie 22nd January LAIT organised a meeting with the Irish Red Cross, Offer a Home, and LAIT to discuss ways forward for future collaboration and to support any families resettled by the Irish Red Cross in the County.

30th January LAIT TEAM are collaborating with Intreo (Department of Social Protection) and Shannon Chamber in delivering a recruitment resource event which for companies seeking to acquire new talent in a cost-effective way and why they should consider linking with Intreo, a public employment service operated by the Department of Social Protection which offers employment services and support to employers to build a more skilled, diverse and inclusive workforce at minimal cost. This event will also include an introduction to the Local Authority Integration Teams (LAITs) and their role in the Community Integration Forum, and in supporting people living in IPAS accommodation find and use local services, such as healthcare, education, employment, and community activities. This event is being hosted by Shannon Chamber in El Electronics in Shannon.

#### Storm Éowyn

In the wake of the red weather alert issued due to storm Éowyn our facilities fortunately experienced no structural damage. However, there were many fallen trees particularly in the Lees Road facility. In The Active Ennis leisure facility, there were two fallen trees while in Lees Road six trees had fallen across the main entrance and numerous others across the walking paths in the wooded area.

The teams responded quickly to assess the facilities and after the assessment of Ennis Leisure and the cordoning off of the trees the facility re-opened the day after the storm. For Lees Road the staff planned works and cleared section-by-section, allowing the facility to partially re-open on Sunday the 26th of January – We were fully re-opened by Wednesday 29th with all the paths cleared.



#### Footfall Report Active Ennis Leisure Complex.

Total Footfall was 14414 for December down 38% from November (22957). The average Footfall per day was 465 down 40% compared to November (765). The highest total recorded footfall was on Saturday December 7th (765). The lowest footfalls fell on the 24th 25th and 26th of December due to the facility being closed for Christmas. The overall lower footfall can be explained by closure and shorter hours during the holiday season and less swimming lessons taking place.

#### Lees Road

Lees road had 12,682 vehicle entries to the park in December which was a decline compared to November (18000) and saw an average of 409 vehicles per day.

January saw the completion of new sports facilities in the Kilrush facilities MUGA (Multi-Use Games Area). The installation features a well-maintained tennis court complete with properly installed tennis nets and posts. A basketball/football area was also installed

#### General update on your operational plan:

- The Pilot with Swim Ireland continues: The 7 Traveller men completed the initial lessons, mixed ability within the group; a further 4 lessons are required to bring 2 up to an equal standard. Still need to get pool time suitable to the group.
- The pilot project in Lisdoonvarna targeting Ukrainian Refugees in conjunction with Weightlifting Ireland is going to be expanded Currently one iterations with A group of cancer survivors who formed a Dragon Boat club with Clare Sports Partnership assistance will be the first group this will now commence on 12th February.
- Couch to 1Km commencing 21st Jan for Housing First Group.
- Fabio has commenced his work experience with Clare Sports Partnership, and through this experience, I hope to empower him to merge his personal talents and knowledge of the community to co-design a programme specifically for the Roma community. After focus groups with Roma Youth we have designed a Yoga (Namaste Yoga Ennis) for the teen girls and Strength and Fitness for Boys (with Spartan Fitness) – aiming for a late January start. Many of the Roma community leave Ennis for the Christmas period and its lead up to return to Slovakia/ Czech Republic.
- Further liaising with GAA Games to develop an adult introduction to GAA aimed at International Protection Applicants. Designing an introduction to GAA for Adults. The ultimate aim is to create a football team comprised of 'New Communities', with an exhibition game in Cusack Park. Going to join CLDC and CISC on their outreach to gauge interest and find a suitable location to host. Still progressing – gathering expressions
- Have been approached by GAA to run a Cul Camp over the Easter for IPA's children, Sponsored by Kelloggs. Will be coordinating 3 other camps via ESF officers in other counties for same cohort. Meetings with Hartnell Wilson – Social Impact Communications for GAA/Kelloggs about finalising details.
- Research Funding The collaboration with Clare Haven on the 'Participatory levels of Children from domestic violent household in team sports' is being proposed to their board and they are considering ethical concerns.

- Liaising with Clare Traveller CSP to do 'walkability audits' from traveller-specific accommodation using the National Roads Authority templates 4 completed.
- A formal referral system to the ESF+ role from SICAP, Local Area Employment Service, Employability, Traveller CPD, Focus Ireland, and Probation Service has been initiated. This is for individuals who present to these services, have had training, are interested in training, or need support getting active/sport again. 12 clients have been referred and met so far. This will be expanded to include the Links Worker client base and internally referred.

  - Lahinch Leisure Centre: Started 8th January 2025 for 10 weeks, at 8:00 PM, 12 people registered.

Lahinch is also considering hosting the main swimming event in March 2025.

- Eire Og / Corofin GAA and Wolfe Tones GAA All-stars Inclusive Clubs are now running outdoor sessions for over 40 children with a disability
- Parteen Meelick have started their All-Stars inclusive club journey with CSP, which will be developed in the months ahead.
- Derg AC have received funding through Dormant Accounts SIDP for an inclusive Athletics and Cycling Programme
- Clare Comets basketball all- stars continue to run their indoor sessions on Saturdays in Ennis National School



### KILRUSH LOCAL ELECTORAL AREA, WEST CLARE MUNICIPAL DISTRICT

January weather has proven challenging for West Clare between the cold spell earlier in the month and Storm Éowyn, the repercussions of which staff are still dealing with. The response from the staff has been immense with staff working out of hours to assist in the clean-up, the response and to ensure access to the road network.

#### Extreme cold weather – Jan 6th to Jan 10th:

The extremely cold snap of weather between the 6th & 10th January was flagged as an Orange level weather alert. The snow & frosty conditions led to dangerous conditions for all road users, travel disruption, and animal welfare issues for farmers. While the treating of priority roads was organised by our Roads & Transportation colleagues in Ennis, crews from the West Clare MD were involved in treating areas not treated as part of the Winter Maintenance Plan, particularly roads and footpaths near community facilities such as schools, doctors' surgeries, churches etc.



#### Storm Éowyn

Storm Éowyn hit Clare on the night of the 23rd of January, this red level wind warning was necessitated as the storm is one of the worst the Country has experienced with wind speeds recorded at the Cliffs of Moher site showing gusts of ~180kph at 3am before the power outage. We anticipate that gusts of ~200kph were experienced in this area albeit wind speed was not recorded after the power outage. The area staff were fully engaged for the clean up operations as significant number of trees fell blocking public roads.



#### Schedule of Municipal District Works 2025:

In the last month the West Clare MD has continued to carry out drainage works, and road surface preparation works prior to the commencement of the 2025 Schedule of MD works.

## THRIVE Ennis - Town Centre First Heritage Revival Scheme



A Part VIII Planning application was lodged by Clare Conty Council on 20th December 2024 to bring forward designs to regenerate/ adapt The Cloister, a significant heritage building and national monument in Ennis, which will be brought back into use while addressing community needs.

The Council expects to apply for Thrive Stream 2 funding in March 2025 to bring this project to fruition. THRIVE is funded by the government under the ERDF Regional Programmes through the Southern Regional Assembly.

A draft Integrated Urban Strategy focussed on heritage is in preparation and stakeholder engagement sessions will be held in late February once a draft is available. This Strategy will be a good opportunity to highlight potential heritage buildings that could benefit from future Thrive funding streams.

## FORWARD PLANNING

#### Kilrush Maritime Training Centre

Work is continuing on



the Kilrush Maritime Training Centre Project to identify a suitable funding stream to cover the remaining funding gap within the project. The Project Team are liaising with the Department of Rural Regeneration and Community Development with respect to due diligence on the projects funding allocation. In addition, Enterprise Ireland are concluding their analysis of the Smart Regions funding scheme to establish if the Kilrush Maritime Training Centre project can apply to this scheme to cover the remaining funding gap.

## Strategic Integrated Framework Plan (SIFP) for the Shannon Estuary

Clare County Council acting as Lead Authority on the SIFP Steering Group and Environmental Sub-Group are currently working on the preparation of a Request for Quotation for the preparation and delivery of an anthropogenic background noise map for the Shannon Estuary. The preparation of this map is timely given the presence for the first time in Irish recorded history of a humpback whale in the Shannon Estuary. The first sighting of the whale was on November 26th, 2024, where it was originally filmed off the Shannon Ferry in the waters between Killimer and Tarbert and the following day the 27th off Ardmore Point, Co. Kerry. The whale continues to thrive in the estuary where it can be seen breaching, making blows and feeding. The Shannon is a busy estuary for large cargo ships carrying thousands of tonnes of material to and from the terminals located in the estuary (Moneypoint, Aughinish, Foynes and Tarbert) this is in addition to the Tarbert to Killimer car ferry together with pleasure boats all which use the waters. This can make for a very noisy underwater environment for marine mammals with anthropogenic noise proven to impact marine species through temporary or permanent threshold shift. Even at low frequency (e.g. 35khz) you can have Temporary Threshold Shift (TSS). Shipping noise is continuous and effects communication therefore there has never been a more important time to understand the background noise levels within the Estuary.


The Draft *Programme for Government 2025 Securing Irelands Future* addressees the issue of accelerating renewables with a commitment that this government will; *Fast-Track Offshore Wind Development by prioritising the publication of Designated Maritime Area Plans (DMAPs) and ensure the relevant agencies are sufficiently resourced to accelerate these developments.* In addition, it gives specific mention to the Shannon Estuary and its role in realising the potential for renewable energy through the inclusion of a commitment to; Work to progress recommendations of the *Shannon Estuary Economic Taskforce central to renewable energy planning, recognising the region's potential.* Delivery of these actions will be central to realising the vast potential for Renewable Energy off the west coast of Ireland which can be serviced through the Shannon Estuary.

#### **Residential Zoned Land Tax (RZLT)**

The Residential Zoned Land Tax came into effect on 1 February. The purpose of the RZLT is to activate land that is zoned and serviced for residential or mixed use to increase housing sup-ply and to ensure the regeneration of vacant and idle lands in urban locations. Local authori-ties are responsible for the preparation of mapping and identifying lands considered 'in scope' and the Revenue Commissioners are responsible for the collection of the tax. RZLT is an annual tax charged at 3% of the market value of 'in scope' lands. The Final RZLT Map for 2025 be published on 31 January 2025 and will show lands subject to the tax. The RZLT an-nual review process also commenced on 1 February 2025 with the publication of the Annual Draft Map for 2026.

There is an opportunity to make submissions on both maps up until 1 April 2025. In relation to the Final Map 2025, landowners may request the local authority to change the zoning sta-tus of land included on the map. In relation to the Annual Draft Map 2026 landowners and members of the public can make submissions regarding the inclusion or exclusion of lands to the RZLT map.

Both RZLT maps will be published on the Clare County Council website along with infor-mation on the RZLT and how to make a submission. Maps are also available for members of the public to view at the Council offices and libraries around the county.

#### Historic Structures Fund (HSF) 2025 and Built Heritage Investment Scheme (BHIS) Historic Thatched Buildings Stream 2025

The 2025 Historic Structures Fund (HSF) and Built Heritage Investment Scheme (BHIS) Historic Thatched Buildings Stream was announced by the Department of Housing, Local Government and Heritage in November 2024. The closing date for applications to Clare County Council was 17th January 2025. Applications received under both schemes are currently being assessed and will be forwarded to the Department for final approval. It is anticipated that the successful applications will be announced in late February/ March.

#### **Section 57 Applications**

Section 57 Declarations are issued to owners of buildings or structures that wish to conduct works to their structures. A Section 57 Declaration determines whether works would be considered exempt from planning. A Section 57 Declaration can also be used to clarify the curtilage of a protected structure, or what elements are to be protected. There is no fee for a Section 57 Declaration.

#### **'Seeds of Hope' Conference and 'Return to Nature Clare Church Biodiversity Project 2025'**

Clare County Council's Biodiversity Officer has signed up six new parishes in the Diocese of Killaloe to participate in the 'return to Nature Clare Church Biodiversity Project' for 2025. This brings the total of parishes in Clare to 16 which includes 18 churches and community groups. An online session was hosted on the 15th of January with participating community members and parish priests and rever-ends in attendance. The initiative is led by Clare County Council and the six new parishes signed up to the initiative include:

- Killaloe (St. Flannan's Cathedral Church of Ireland) Dean. Richard Marsh and Killaloe Community

- Quin (St Mary's Catholic Church, Quin) Quin Tidy Towns
- Tulla (SS. Peter & Paul, Tulla) Tulla Tidy Towns
- Doonbeg (Church of Our Lady Assumed into Heaven) -Doonbeg Tidy Towns

On Saturday, 25th of January, Clare County Council's Biodiversity Officer gave a number of work-shops and presentations at the 'Seeds of Hope' conference in Mallow, Cork. The conference was well attended with community groups from Kerry, Cork, Limerick, Tipperary and Clare present. The con-ference aimed to promote biodiversity actions on church grounds. The 'Return to Nature Clare Church Biodiversity Project' was used as a flagship project for community groups across Munster to follow and outcomes and learnings of the project were shared with other dioceses. The conference was organised by the Laudato Sí Working Group and Bishop Fintan Monahan was in attendance. The Heritage Council's Biodiversity Officer Network is seeking to adopt the Clare Church Biodiversity Pro-ject in other counties/LA's in 2025 including Limerick, Cork City, Galway City, Mayo, Leitrim, Wexford and Kilkenny.



#### World Wetlands Day Event 2025

Clare County Council's Biodiversity Officer has organised an event to celebrate World Wetlands Day scheduled for the 4th of February. The event will see the launch of the Clare Wetland Story Map, the launch of the new wetland guidelines aimed at community groups and landowners 'Community Ac-tion: A Beginner's Guide to Wetlands' which was carried out in conjunction with the Community Wetlands Forum, Clare County Council and Monaghan County Council. The event will also provide an update on the Clare Wetland Field Survey 2024. Speakers will include Laurence Fullam of the Community Wetlands Forum, Patrick Crushell and Poppy Overy of Wetland Surveys Ireland and Barry O'Loughlin Biodiversity Officer with Clare County Council. This event is aimed at communities and landowners undertaking biodiversity actions in their locality and to promote wetlands as an educa-tional resource.

The Clare Wetland Story Map is a new online digital interactive map that profiles ten wetland sites the public can visit and value in County Clare. It also includes a description of wetland habitats found in County Clare and a list of resources for communities, schools and landowners. The new wetland guidance 'Community Action: A Beginner's Guide to Wetlands' is aimed at community groups and landowners who wish to embark on a wetland conservation project and to encourage the promo-tion of wetlands in their local area. This could range from including wetlands in Community Biodiver-sity Action Plans, undertaking a conservation project to hosting walks and talks. An update on the Clare Wetland Field Survey will also be provided by Wetland Surveys Ireland.

The project is funded through the Lo-cal Biodiversity Action Fund (LBAF) (administered by National Parks and Wildlife Service) and Clare County Council. # LOCAL ENTERPRISE OFFICE

- Mentoring: LEO Clare commenced the year with a substantial demand for one-to-one mentoring support. Thirty clients were assigned expert mentors to assist them in enhancing their businesses.

### DERELICT SITES

The Derelict sites team are currently dealing with 272 properties that are considered derelict. We continue to have very high levels of activity and engagement with owners and their representatives. Initial engagement with owners or their representatives is key to resolution of the issues of dereliction and to gain an understanding of the various reasons why the properties are in a derelict state. Where derelict properties are sold by the owner, we commence engagement with the new owners of those properties to ensure they are aware of their responsibilities under the Derelict Sites Act, 1990. We are also seeing a consistent number of planning applications for property refurbishment/extension and it is clear from driving around the county the level of work ongoing on individual properties. We are advising property owners of the vacant property refurbishment grant if the property is suitable for residential use. With time and effort, working with owners, financial institutions and other departments, there are definite options for positive re-development and revitalisation of many such derelict sites.

The table below provides a snapshot of the activity in January 2025 and year 2025 to date and the comparative figures for the full year 2024. The engagement with owners has proved very positive and helpful in addressing issues.

### **Compulsory Acquisition of Derelict Sites (CPO)**

In 2023, the Department of Housing, Heritage and Local Government launched a CPO activation programme for local authorities which set targets for CPOs for each local authority. The Table below sets out the status of CPOs commenced by the Derelict Sites Team since 2022 to the current year.

In addition, the Urban Regeneration and Development Fund will provide funding for CPOs on a rolling basis in the town of Ennis with the objective being that these properties would then be sold on the open market. A particular emphasis will be on properties that have potential for residential use. One such CPO is with the PRA for registration and works have recently been completed in order to safeguard the property in the interim. A second CPO commenced in August 2024 and has been lodged with Taillte Éireann. A particular focus on properties in the town of Ennis has resulted in a number of properties coming to market or making plans for site development.

#### **Derelict Site Levy**

Determination of valuations on the derelict sites which are on the Derelict Sites Register commenced in 2023 and notices of valuation have been issued to 18 property owners in 2024. Three owners appealed the valuation to the Valuation Tribunal and while decisions are awaited on two appeals, one appeal by an owner was rejected. The levy is an annual levy while the property remains on the Derelict Sites Register and amounts to 7% of the value of the property, on an annual basis. Assessment of valuations and billing

of the levy will be further progressed during 2025 and it is intended that all properties on the Derelict Sites Register will be valued for the purposes of billing the levy. This levy will go towards the cost of billing and collection of the levy and resourcing of derelict sites function.

### VACANT PROPERTY REFURBISHMENT GRANT - FOR DERELICT AND VACANT PROPERTIES

The Council welcomes the inclusion in the draft programme for Government of the intention to extend the Vacant Property Refurbishment Grant to 2030. If there are any changes to the scheme, the Vacant homes Team will ensure that they are communicated as soon as they are announced.

The level of approvals of the Vacant Property Refurbishment Grant by Clare County Council has is at  $\leq 19.87$  million as at 25th January 2024 (330 grant applications approved or 66% of all applications), with further approvals due to issue. This is a very significant investment in housing in County Clare and the work ongoing around the county on renovations and extensions is very visible. The Vacant Homes Team continues to advise applicants on all elements of the scheme and is available to meet with individuals to take them through the process.

The Grant is making a real difference in boosting the supply of rental properties and properties for permanent residence and will deliver on a key priority of 'Housing for All' National Policy and the Vacant Homes Action Plan, the key objective of which is to reduce vacancy and dereliction in our cities, towns, villages and rural countryside and provide more housing options in the process.

A number of walk-in advice clinics were held in late 2024 with over 50 property owners coming in to meet the Vacant Homes Team for advice regarding making their applications, information required etc. These were held in Ennis, Miltown Malbay, Scariff and Sixmilebridge. Any applicant can meet with the Vacant Homes Team in Áras Contae and Chláir by appointment. The breakdown of Grant approvals by Municipal District is shown in the Table below.

We continue to have high levels of enquiries and applications for the Croí Cónaithe Vacant Property Refurbishment Grant and have passed the figure of 500 applications in early January 2025. We are in the top eight local authorities in the Country in relation to application numbers. Our response time for initial assessment of new applications is generally four to five weeks.

At the end of January, we have paid out €4 million to 71 property owners in County Clare who have completed works and many others are in the process of submitting their claims for payment. The final site inspections are organised and the administration of the financial and legal elements of the grant are completed. The level of claims for payment is increasing every day and the Team work closely with owners on this process.

### Local Authority Purchase and Renovation Loan

A new loan has been launched by Government called the Local Authority Purchase and Ren-ovation Loan. It is a governmentbacked mortgage and loan that helps people to buy and renovate a derelict or uninhabitable home. The loan is for firsttime buyers, and 'fresh start applicants', who have been unable to get funding from commercial lenders. It is an exten-sion of the Local Authority Home Loan. The applicant must qualify for the Vacant Property Refurbishment Grant to get this loan. The Housing Department will administer this loan and work closely with the Vacant Homes Team.

### **Other Points of Information**

- Changes to the grant were announced in late 2024 to be in line with the Energy Performance of Buildings Directive (EU/2024/1275). In order to meet the timeline in Article 17(15), the Vacant Property Refurbishment Grant will no longer fund the installation of stand-alone boilers powered by fossil fuels, for new applications from 1st December 2024. This is being notified to all new applicants.
- 2. The breakdown of applications between urban and rural

areas has remained consistent - 56% of applications are for rural areas of the county and 44% for properties in towns and villages.

- 3. To date, 71% of applications are for properties to be used as principal private residence (333 properties) and the balance of 29% are for rent. This has remained fairly consistent in recent months.
- 4. To date 20% of applications have been either withdrawn or refused. This can arise if the purchase of a property falls through, if the property has not been vacant for the two year period or where proof of eligibility criteria is not possible. We assist applicants on all elements of the application process and are receiving positive feedback in this regard.

### ENNIS MUNICIPAL DISTRICT

Following the Christmas Holidays, the Ennis Public Realm Contractor returned to site on Monday January 6th 2025 with new works commencing at the junction of Station Road and O'Connell Street along with closing out of other existing works areas throughout the town. Along with the normal day to day and various project works, the Area Staff were significantly called upon to deal with the fallout from Storm Eowyn later in the month and the consequential damage and humanitarian issues arising in its aftermath. I would like to thank all staff involved along with our colleagues across the organisation and indeed the various external agencies that we engage with in such events.

Some of the key works progressed throughout the MD area in the past month include the following:

### **Trip Hazard Repair & Surface Water Works**

Trip hazard repair works were carried out in multiple locations around Ennis Town Centre including Lower Market Area, Tobarteascain, Abbey Street and Bank Place. Other defect repair works including surface water infrastructure on Cusack Rd.

New surface water infrastructure was also constructed to alleviate localised flooding concerns in Cahercalla Rd, Glenina and Cloughleigh Rd Ennis.



### Illegal Dumping Clean Up's

Having been brought to the attention of Ennis MD, our maintenance crew carried out clean ups of multiple incidences of illegal dumping in around Ennis. These areas included Lower Market St Carpark, Cappahard and Clancy Park estates. Each incident was reported to Clare County Council Environment Dept for further investigation. Some of these cleanups were co-ordinated with An Garda Siochana and local community groups.



### **Pothole Repair Works**

The outdoor crews are continuing their schedule of road defects

and pothole repair works in the Ennis area. With adverse weather conditions encountered in December and January and with more events on the horizon, incidences of road defects are likely to come to light more frequently. Our crews have undertaken repairs this month in areas including Kilrush Rd, Clon Rd Business Park,



Phoenix Court, Dalcassian Drive, Bishopscourt, Abbey St Carpark and Brookville estate Ennis.

#### **Ennis MD Winter Maintenance Works**

Ennis MD crews, during adverse weather conditions throughout

December and January, carried out winter maintenance measures on public roads and footways which fall outside the routes as identified under the countywide Winter Service Plan. These works included cleaning of drainage gullies and salting of roads. These works extended to the Ennis town area and surrounds, and also heavily traf-



ficked footpaths in areas of the town centre including churches, nursing homes and schools.

### Traffic Light Upgrade Works – Carmody Street Ennis

Following critical failure of the traffic lights at the junction of Carmody St, O'Connell St and Turnpike Rd, civil and infrastructural works were scheduled and carried out with immediate effect. These works included new underground ducting and cabling, new light heads, vehicle loop detectors and push buttons. There has also been a new connector cable linking both this junction and the 4-way junction at the Kilrush Rd to allow for a more efficient traffic flow in the area. Permanent reinstatement works to the carriageway are to follow in February.

### **Ennis Flood Relief Works**





Tree removal works were carried out in the river Fergus where trees were damaged and displaced as a result of recent adverse weather conditions in the area. An external Contractor was appointed to secure and manage the trees on site. This intervention ensured the normal flow of water within the river was maintained and limited the potential risk and impact to bridge and flood relief infrastructure within the town.



### **New Speed Limit Signs**

During January, Ennis MD Roads crews were busy installing poles and signs on the local roads throughout the Ennis Municipal District as part of the role out of the new 60Km/H speed limits that come into force on February 7th 2025. The new signs are located on the intersection of all Local Roads with Regional and National Secondary Roads.









**Christmas Lighting** 

All Christmas lighting was removed in advance of the recommencement of the public realm works. Additional locations have been identified for the storage of the new items which were added to this year's festive light offering including the 6-meter sustainable tree and the projector. We hope to see the projector lighting up O'Connell square again during the coming year during other holiday events.

### **Other Key Strategic works**

In addition to the aforementioned, Ennis MD staff continue to work on a number of other key projects such as the Area Based Transport Assessment (ABTA), the Town Bus Project and also, on a cross-directorate basis with our colleagues and the various Government Departments in advancing a number of other works throughout the Town and Environs. These include the Ennis Public Realm Project, the LIHAF Access Road project, the THRIVE project at the Cloister and the Tulla Road and Clare Road Active Travel Projects, potentially new URDF applications, etc. We also work closely with our DAC colleagues in developing the ambitious plans outlined in the Ennis 2040 Economic & Spatial Strategy. Related to E2040 matters, Members will be aware of some staffing changes in recent weeks whereby former COO Kevin Corrigan and PM Rob Heneghan have moved on. We wish them well in their future endeavours. Council Head of Enterprise, Padraic McElwee has been appointed as Interim COO in the meantime.

# CAPITAL DELIVERY / PROJECT MANAGEMENT OFFICE

Ennis Public Realm Regeneration (Project B)	The contractor remobilised in early January, with the ending of the 6 week construction stand-down. An intensive works programme has now being established with new civils and paving crews being deployed to the Cathedral area, to supplement other resources assigned elsewhere on O'Connell Street, Carmody Street junction and at High Street. The contractor also has completion crews dedicated to completing snagging works, and completing paving works where certain unfinished sections. In February, the contractor will be commencing works at O'Connell Square, in addition to advancing
	works at O'Connell Street/Market Street junction. The high quality Public Realm design ensures that a shared surface multi-modal pavement is in place throughout the town centre and indeed the benefits of this were clear to be seen and experienced throughout December 2024, as the O'Connell Street Thoroughfare was brought to life with visiting shoppers, and played host to many street events.

	This provides a vision of what is yet to come for other areas of the town centre (Barrack Square and Street, O'Connell Square, and Bank Place), all scheduled for completion in 2025. Consultation with impacted traders and stakeholders is ongoing, and the contractor has appointed a Public Liaison Officer in this regard, in line with Works Requirements. A focused Stakeholder Consultation event was held on 9th December 2024 to review the updated phasing plan and inform stakeholders as to upcoming works phases. The contractor is also issuing weekly newsletters to inform of upcoming works. (Subscribe to <u>ennispublicrealmb@shareridge.ie</u> ). The contractor, project team, and Clare County Council Resident Engineering staff are available to help traders and the public with any concerns and to mitigate impacts from the works wherever possible. It continues to be necessary to close streets to allow these works to be completed safely, and the project team and contractor, together with Ennis MD are working hard to coordinate activities to keep traffic impacts to a minimum and ensure that Ennis is kept open for business throughout the remaining months of this project. In areas of narrow street width works will be completed Out of Hours so as to minimise impact on trade and facilitate pedestrian movement through these street sections.

### FIRE & BUILDING CONTROL SECTION

### **Training Courses**

Clare County Fire & Rescue Service personnel underwent the following training course during January - Climate Action Awareness Training completed in all 7 Fire Stations.

### Storm Éowyn - Fire Service Response

In the early hours of Friday, January 24th, all on-call personnel were placed on standby at their stations from 2:00 AM to 11:00 AM to avoid the need for travel during the Status Red Wind Warning issued for Storm Éowyn. As part of the standard protocol for severe weather events, the Officers in Charge in each Fire Station carried out Dynamic Risk Assessments (DRA) for any alerts to assess whether it was safe to respond. During the storms peak, emergency calls were limited to life-threatening incidents, while other situations were prioritised and all addressed once the Red Warning had expired and conditions allowed for a safe response.

Across the county, Clare County Fire & Rescue Service, working alongside Clare County Council personnel, handled over 130 reports of storm-related damage by Friday afternoon. These included widespread fallen trees, road blockages, structural damage to buildings, as well as supporting ESB Networks and Uisce Eireann where possible. The Fire Services key objectives were to ensure that secondary roads remained passable, while also addressing local roads and infrastructure where needed, to support local and business continuity as travel resumed on Saturday morning. All seven brigades of Clare County Fire & Rescue Service responded to a significant number of emergency calls, with recovery operations expected to extend into the following week.

Our Environmental Awareness Officer is the designated Information Office (AIE Officer) under the Access to Information on the Environment Regulations for Clare County Council. During 2024 15 AIE requests were received by Clare County Council and processed. There was one appeal to the Commissioner of Environmental Information during 2024. There have been 3 AIE requests received to date in 2025.

### Gardening

The New Year is an ideal time for the planting of new trees, and with this the Gardening Team undertook the planting of a series of new trees and hedging around Áras Contae an Chláir (Gardening Photo 01). The planting consisting of birch and holly, both native and pollinator friendly species.

There will be many long-term benefits associated with this new planting, including the improvement of the aesthetic of Council headquarters, together with encouraging local biodiversity, improving local air quality and positively impacting climate change through the uptake of carbon dioxide.

Given the relatively mild winter experienced to date, the Gardening Team has already commenced certain tasks more normally associated with the spring and summer. In January, the team commenced the weeding and preparation of flower beds.



This work is essential in ensuring strong plant growth during the summer season and typifies much of the unseen work that the Gardening Team undertake to ensure that Ennis and Clare look its best throughout the year.

The Christmas themed planters that were located throughout Ennis Town in December were very warmly received by both local businesses and the wider public. Given this success, the Gardening Team is committed to maintaining these planters at locations around the town and will work in collaboration with the Ennis Municipal District and Project Management Office, to ensure the town continues to act as a welcoming space for business, tourists and the entire community.

### Waste Enforcement

### Inspections of Permitted and Unpermitted Sites

Inspections of two permitted and four unauthorised facilities were carried out by the Waste Enforcement team in January. The unauthorised facilities were inspected as a result of complaints. Follow-up enforcement action was taken in the case of the unpermitted sites. Warning letters were issued. Follow-up inspections have taken place to monitor compliance. Two have been complied with. The other two sites are still within the timeframe for compliance.

The permitted sites were inspected to monitor compliance with their permit conditions, to achieve positive environmental outcomes for the receiving environments.

### **Enforcement Notices and Warning Letters**

In January two warning letters were issued because of unauthorised waste activity. A further three warning letters were issued under the **Air Pollution Act, 1987, as Amended** as a result of complaints of unauthorised burning.

One notice was issued under Section 9 of the Litter Pollution Act 1997, as Amended and two notices were issued under Sec-

tion 14 of the **Waste Management Act 1996, as Amended**. These are being monitored for compliance.

### **Cleanups at Illegal Encampments**

On Wednesday January 15th a joint cleanup took place at two illegal encampment sites in Ennis. Staff from Ennis MD (two crews and two engineers), Housing and Environment were present, as well as two members of An Garda Síochána. A trailer load of rubbish consisting of chairs, nappies, buggies and household waste was removed from the locations and disposed of at the Central Waste management Facility in Inagh. A significant investment of resources was put into cleaning these sites in December 2024.

### Air Pollution Act 1987 (Solid Fuels) Regulations 2022

Follow-up inspections to check compliance with the Retail Register for Clare are ongoing and will continue. The register was compiled, and retailers were written to in 2024, advising them of their responsibilities under the above Regulations. Monitoring of door-to-door and online solid fuel sales is also taking place.

### Storm Éowyn

The 2024/2025 Irish storm season runs from Sunday 1 September 2024 to Sunday 31 August 2025 (inclusive). Storm Éowyn was the 5th storm of the season and it arrived in the early hours of Friday 24th January. The storm impacted services provided by the Environment Section such as opening of our Civic Amenity Sites. While there was only minor damage to equipment there were some fallen trees that required removal before it was safe for the public to access the sites. Electrical power to both Lisdeen and Inagh was cut off, however we were able to operate from on-site generators.



### **CLIMATE ACTION**

#### Community

The Climate Team in Clare County Council collaborated with Ennis Tidy Towns to host a Tidy Towns Networking event. This was held on December 10th in the Civic Room in the Buttermarket Building and Tidy Towns Groups from around the county attended. The aim of this event was to enable tidy towns groups from around the county to network and build capacity. The evening was opened by Councilor Mary Howard who delivered a welcoming address. This was followed by a presentation by the Clare County Council Biodiversity Officer on what simple actions tidy towns groups can take. Clare Community Climate Action Officer gave a presentation on the Community Climate Action Programme focusing on the types of projects Tidy Towns Groups can undertake. Gabriella Hanrahan from Quin Tidy Village also presented on the evening about the actions they are currently undertaking. A series of follow up networking events is planned with the next one due to take place in February.





The Climate Team participated in a sustainable tourism workshop in Kilkee on Wednesday December 4th. The event was well attended by businesses and community groups from the peninsula. LEO presented on the opportunities present for businesses to leverage funding towards energy efficiency upgrades. The Climate Action Co Ordinator presented on the Climate Action Plan adopted by Clare County Council and focused on the benefits that can be reaped by acting on Climate.

### Energy

### TRESS Project:

Tipperary Energy Agency (TEA), Vivid Edge and Technological University of the Shannon (TUS), supported by the EU LIFE Programme secured grant funding to carry out Investment Grade Energy Audits on selected public buildings in Munster. Clare County Council was successful in its application to have Ennis Leisure Centre and Aras Contae an Chlair included in the fully funded programme known as TRESS ((Transforming Renovation in the Atlantic Seaboard South). The Climate Department within Clare County Council has worked in close association with TEA over the past 18-months in the preparation of the preliminary design to allow the Investment Grade Energy Audit to be completed. Staff from TEA and Vivid Edge recently presented a summary of the outcomes for Ennis Leisure Centre to Clare County Council staff in the Civic Room at the Buttermarket building.



#### **ISO Audit:**

Clare County Council has an Energy Management System (EnMS) accredited to the International Standard ISO 50001 in operation since 2018. As part of the certification process, annual Surveillance Audits are carried out by the National Standards Authority of Ireland (NSAI). The 2025 Surveillance Audit will constitute a one-day on-site inspection by an NSAI Auditor who will conduct a thorough examination of all documentation within the EnMS. It will also be necessary for selected staff within the organisation with responsibility for the energy usage of our Significant Energy Users to be available to allow the Auditor to interrogate data analytics and operations. After conclusion of the on-site audit, the Auditor will prepare a report for NSAI giving a recommendation on whether the accreditation of the EnMS can be maintained for a further 12-month period.

### WATER

The Rural Water Office continues to support group water schemes to ensure a robust and sustainable quality and quantity supply of water is available.

The Department has decided to take a phased approach to approval of funding with a focus on water quality issues for the first phase, namely Measures A1, A2, A3, A6 and A7. Funding applications for the Taken in Charge of Public Group Water Schemes under Measure A6 are not part of this first phase of funding. In addition, the Expert Panel is continuing its work in its evaluation of applications received under Measure A4, A5 and A9. We have informed all successful Group Water Schemes. In December the Clare Rural Water Programme Office held an update meeting in relation to the Multi-annual Rural Water Programme 2024-2026 announcement. The purpose of this meeting was to update the schemes recommended for funding under Measure A6 Taking-in-charge of group water schemes and assist in the development of a pathway to successful project delivery.

Group Water Scheme Taking in Charge applications continue to be progressed by the Clare Rural Water Team. The Rural Water Team is working with Group Water Schemes in assessing the need to carry out emergency works and applying to the Department for exceptional urgent capital works for once off funding as they arise.

Applications for Group Water Scheme annual subsidy which is available to fund operational costs of group water schemes providing water for domestic use continues to be processed by this office. All applications under the 'Grant for Improvement Works to a Private Water Supply' under the Rural Water Programme continue to be processed by the Rural Water Team, 6 applications have been received to date for 2025. Post works final inspections for works within the last 12 months are ongoing.

# Rural and Community Development Officer's funding advice clinics

The Shannon MD's Rural Community Development officer hosted two walk-in clinics in the Shannon Oakwood Hotel and Clonlara Community Centre. These clinics sought to advise and support community groups/organisations in project development and funding opportunities. These clinics coincided with the application periods of two funding opportunities for community groups: The Clare Local Area Grants Scheme (CLAGS) and the Local Enhancement Programme (LEP). Attendees were able to discuss these funds with the Rural and Community Development Officer and receive guidance on preparing funding applications. The clinics had a strong level of attendance from a broad range of community groups and organisations. This level of engagement provides a strong foundation for future collaboration within the Shannon MD and the community groups.





# Shannon MD Accreditation- Health and Safety ISO 45001

ISO 45001 is an occupational health and safety standard that provides a framework to improve employee safety, reduce workplace risks and create better, safer working conditions. Shannon MD have now been awarded the ISO45001 standard. The standard will remain in place for three years. There will be annual surveillance audits.
