
create positive change together.

Extension to Drumcliff Burial Ground:

The Burial Grounds Unit are progressing plans to extend the county burial ground at Drumcliff, Ennis. The proposed development is designed to address the growing need for burial space and aims to enhance the existing burial ground while creating a tranquil and reflective environment. The plan includes an addition of 413 double plots, including provision for ash plots, to meet the increasing demand for burial space. Additionally, a future Columbarium Wall is proposed which can contain up to 470 niches. The proposed extension aims to create a modern lawn cemetery that responds to the needs of our community. The design is driven by principles of accessibility and looks to promote biodiversity through the provision of planting and trees. An application to extend Drumcliff Burial Ground was submitted to An Coimisiún Pleanála in September.

HEALTHY CLARE

Healthy Clare/Creative Ireland Micro Fund 2025

A number of Healthy Clare micro funded projects were completed during the month of September.

Clare Traveller Community Development Project: Gym Wellbeing Project.

This programme is co-funded by Healthy Clare and Clare Local Development Company and takes place in Active Ennis facilities. The gym initiative is designed for 10 Traveller men, emphasising the importance of mental health, physical health, and social inclusion. The project commenced with the aim of fostering a supportive environment that promotes overall well-being through fitness and at a mid point review it was found that the gym programme for Traveller men is achieving its objectives by making strides in physical fitness, supporting mental health, and encouraging inclusion. 'The initiative not only improved physical health metrics but also significantly contributed to the mental and emotional well-being of the participants. Continued support and expansion of such programmes are essential for sustaining these benefits and promoting a healthier more inclusive lifestyle in the Traveller community.'

• West Limerick Resources, Social Farming:

Social Farming is the practice of offering activity on family farms as a form of Social Support service. In Social Farming the farm remains a working farm at its core but invites people to participate in the day to day activities on the farm.

Three participants were supported to engage in Social Farming activity with farms in Feakle and Inagh because of the Healthy Clare Micro Fund. The evaluation showed that 'All participants are thoroughly enjoying their social farming placement and positively engaging in health enhancing activities.'

• Lisdoonvarna Failte Fitness Programme: Lisdoonvarna

Failte ran a series of fun, inclusive fitness programmes to support the community to develop an awareness of how to live well through movement and social engagement. Activity included Zumba classes and mindful movement.

Peer Led Wellness Café Walks:

Supported under the Healthy Clare Micro Fund, Creative Ireland collaboration, The Peer Led Wellness Café has completed a series of wellbeing walks engaging local historian Dr Jane O'Brien. on the 8th of September. Feedback from the walks has been very positive and the café hopes that social opportunities beyond the café can be explored over the coming months.

On 2nd September 2025, the Clare Age Friendly Programme proudly participated in the Age Friendly University initiative meeting - a pivotal moment in Ireland's journey toward inclusive education.

The University of Limerick is set to become the first institution in the country to adopt the World Health Organization's four-stage process in pursuit of official recognition as an Age Friendly University. This structured approach includes commitment, assessment, planning, and implementation - all aimed at creating a welcoming, accessible, and enriching environment for learners of all ages.

This collaboration marks a transformative step forward in promoting lifelong learning, intergenerational engagement, and age-inclusive policies within higher education. Clare's involvement underscores the region's dedication to championing age-friendly values across communities and institutions.





Cultural Companions Event

North Clare Positive Aging & Wellness Fair

The North Clare Positive Ageing and Wellness Event took place on Saturday, September 6th, and was met with an enthusiastic and high turnout from the local community. Designed to promote health, wellbeing, and active ageing, the event offered a full day of engaging presentations, physical activities, and opportunities for social connection. The day began with a warm welcome and opening remarks from Joe Killeen, setting a positive tone for the sessions ahead. Carmel Burke, the event coordinator, guided attendees through the day with care and attentiveness, offering both the initial health and safety briefing and closing thanks.

Throughout the event, participants enjoyed multiple exercise sessions led by Niall and Trish Cleary, which encouraged movement and physical engagement. Sharon Cahir of Cahir Solicitors in Ennis provided valuable legal insights tailored to older adults, followed by an interactive Q&A. Consultant Nutritionist Grainne Travers shared expert advice on healthy eating and lifestyle choices, while Sgt Cathriona Houlihan from the Clare Crime Prevention Unit and Ronan Buntung of Task Community Care addressed safety and support services available to the ageing population. Jenny O'Mara, Social Worker for the Older Person with Eimear Sutton Horan on the Clare Home and Day Care Services, concluded the speaker lineup with a thoughtful overview of care services and support networks in the region.

Overall, the event was a resounding success, reflecting the strength and vibrancy of the North Clare community. It fostered awareness, empowerment, and connection among older adults, and highlighted the value of collaboration in promoting wellness and ageing with dignity.





Healthy Ireland

Healthy Ireland Local Government hosted a national two-day conference - "Building Resilient Futures through Local Government" September 11th -12th 2025, in the SETU Arena, Waterford

Clare Libraries

Clare Libraries launched their Skills for life programme in September. The programme will offer support in six key areas: Basic Digital Skills, Financial Literacy, Media Literacy, Business and Employment Skills, Health Awareness and Sustainable Lifestyles and Environmental Awareness. The initiative started with a programme of sustainability events in 5 libraries throughout the month.

The "Books at Bedtime" initiative ran from 20th August to 18 September. Each child in Clare aged 3 and under was offered a free copy of the book 'Say Goodnight Like This' by Mary Murphy to read together with their parents at bedtime. Parents also received information on how to establish a good bedtime reading routine and the benefits of reading to your child at an early age.

Children's Book Festival - a whole month of library based activities for children was launched, with a full programme of over 40 events scheduled for October throughout the county. Primary School classes are invited to attend workshops, talks, theatre productions and author visits with some of Ireland's best loved children's authors and storytellers.

Skills for Life

There were 53 Skills for life events in Clare libraries this month. They included

- 40 drop-in digital sessions and 1 smart phone class.
- 7 Sustainability events
- 4 media literacy events
- 2 Health awareness events

Healthy Ireland

A walk-in health check was organized in collaboration with HSE nurses as part of the recent Pop-up literacy event in Kilkee Library.

Attendees were offered complimentary blood pressure checks, diabetes screening, and general health advice. A total of 55 individuals participated in the community health initiative. Shannon Library hosted a talk with Mental Health Ireland on the topic of 'The Five Ways to Wellbeing.' This talk offers practical steps to people to improve their mental health and lead a more balanced and fulfilling life

Creative Ireland Programme

The Clare Culture and Creativity Team, which includes representatives from the Library, Arts, Heritage, Local Enterprise Office, Climate Action, Biodiversity, Museum, Healthy Clare, Local Studies, and Rural Development sections of our Council, receive funding from Creative Ireland to support the development of cultural and creative initiatives throughout the county. This funding enables the team to strengthen community engagement and enhance creative capacity through a wide range of programmes and projects. Among the projects supported were the Cultural Companions Creative Event at Temple Gate Hotel, delivered by the Age Friendly Team, and the Heritage Office's programme "Reading Your Local Landscape", a course designed to explore Clare's natural, built, and cultural heritage.

Creative Ireland also supported a multidisciplinary event titled "Lost in Briars", which featured a panel discussion on the evolving relationship with the bramble - one of Ireland's most common plants - and its ecological and cultural significance. The event included a Botanical Art Class facilitated by Jane Carkill and a live music performance by Simon O'Reilly, both of which focused on the bramble and its fruit, the blackberry. This event was held at the Courthouse Gallery in Ennistymon.

In addition, Creative Ireland funded the creative workshops for Music Generation's Folk Festival. This inclusive festival promoted participation, education, and heritage, offering young musicians the opportunity to engage in collaborative learning and perform alongside professional artists.

Two Culture Night events also received support from Creative Ireland Clare. The first," Seal le Ceri" in Scéal Eile Books, was an Irish language event where artist Ceri Garfield discussed her artistic practice and presented her work. The second featured North Clare Refugee Allstars, a unique musical collaboration with asylum seeker musicians living in IPAS centres across County Clare, who performed in Shannon in collaboration with Mná le Chéile Women's Shed and developed in partnership with Clare Local Development Company and the Clare Immigrant Support Centre.

Local Studies and Archives

Local Studies and Archives have received a donation of documents relating to the Vandeleur estate in Kilrush. These date from the 1790s to the 1920s and contain a wealth of detail on the running of the estate. Thanks to the Noctor family of Limerick for the donation. A donation of books relating to the history of Clare was donated by the Collins family of Clare Road. This collection belonged to Michael Collins, a prominent local historian. A presentation was given to the Women's PROBUS group, on the holdings in the Local Studies and Archives Centre.

A collection of papers relating to the Creagh family of Dangan, Quin, was donated to Archives. The ongoing cataloguing of the Holohan Collection has uncovered an interesting find, a letter from the Clare MP William Redmond.

RURAL DEVELOPMENT

Clare Museum

The Museum winter lecture series has been finalised with lectures taking place between October to May 2026. The temporary O'Connell Exhibition is on view at the museum. Four new items were added to the long-term exhibition, replacing items that have been on display since the museum opened. A blog on two of the items was written and placed on the museum website.

A further 27 objects were catalogued onto the Museum database, bringing the total for the year to 248. There were 46 new items photographed and uploaded to the museum website and there were five social media posts during the month.

Clare Arts Office

Culture Night took place on Friday 19th September with thousands of people enjoying the arts in over 15 towns and villages across clare with 17 events in Ennis. There were over 45 free events to enjoy and was truly 'One night for all' with events for all ages and abilities included on the programme. Highlights include Súils first

ever culture night events, a collage workshop with Súil's own Aoife Byrne and Under the Ambient. A live mixed film from João Tudella with a live soundtrack by Simon O'Reilly, Aisling Lyons and Dermot Sheedy (synths and electronics). The event "Emain Ablach" took place in The Attic in Doolin Hotel and treated audiences to a suite of music composed by award-winning musician and composer Neil Ó Lochlainn and performed by a thrilling 10-piece ensemble featuring some of the best musicians in the country.

Súil, art gallery, welcomed 656 visitors from August 13th – September 22st including 55 at the exhibition opening of SIÚNTA. Súil began advertising its end of year show, ANNUAL OPEN 2025, which invites emerging and established artists to submit one work in any medium of their choice. Cultúrlann Sweeney Kilkee was very busy in September with the Kikee Arts Festival, the Kilkee Playwrights Festival, the 1950's Festival and performances by the young members of the local theatre company Crack'd Spoon. Clare Youth Theatre started back with a full house. A total of 48 members have registered with a waitlist in operation for both under 12s and over 12s groups. A new Kilkee Youth Theatre due to start in October is booked out. The final Riches of Clare concert of the year took place at Feakle Trad Festival.

The Arts Officer held five support and advice meetings with local artists and arts organisations in September and launched the "Meet the Makers" Exhibition in glór. She participated in the development of the new Music Generation Clare strategy. Street art and murals were completed in Ennis, Ennistymon and Lisdoonvarna as part of the PRISM scheme. Three exhibitions took place in Kilkee, Scariff and Ennis and one new artist took up residence at the EASI Studios in Ennis.

The Arts Officer had two slots this month on Clare FM.

The Schedule of Works 2025 carried out by the Municipal District under its road maintenance and road improvement programme include, pavement repairs, surface dressing, white lining, road signage, drainage works, grass and verge trimming along routes is coming to a conclusion with an additional roads incorporated into the original schedule of works including - Caproe L-8052, Knockdonagh-Truagh L-3048 and Lackabranner bridge.

With the allocation of supplementary funding, an additional Local Improvement Schemes (LIS) project was approved for Ballyvorgal . Furthermore, all four Community Involvement Schemes, Oatield, Glenboniffe, Clashduff & Ballyscanlan are on track for completion within the next two weeks.

The Specific Improvement project at Ogonnelloe valued at €220k has now entered the Section 38 public consultation phase. The proposal includes the installation of traffic calming measures based on the detailed design submitted by the Road Design team. Submissions are invited until 4:00 p.m. on Monday 20th of October 2025.

In terms of drainage works, five out of eleven projects have been successfully completed. Crews will continue work on the remaining six projects over the next two months



Housing Allocations

New Development at Beal an Inbhir Kilrush

The Allocation process in relation to the new social housing development situated at Beal an Inbhir, Kilrush is completed, and the new tenants received the keys to their new homes on 22nd September last. This development which was advertised on the CBL website in early September attracted 80 bids for the 3 bedroomed and 131 bids for the 2 bedroomed bouses. The 8 units allocated comprise 4 no 3 bedroomed houses and 4 no 2 bedroomed houses. This is phase 1 of this development and phase 2 will be advertised later this year.

Tenant Purchase Incremental Scheme

There remains significant interest in the LA Tenant Purchase Incremental Scheme. We currently have 19 open cases at various stages of the process. The sale of seven properties under the tenant purchase scheme completed in 2024. Seven properties have been sold to date in 2025. It is expected that more sales will be completed in Q4 of 2025.

Having consulted with elected members in relation to maintaining our newer stock we have agreed that properties purchased or built since 1st January 2016 will not be available for sale under this scheme. This can be reviewed at end of

current Housing Delivery Plan period in 2026. We have also agreed that 1-bedroom properties and specially adapted units will not be available under the scheme.


Traveller Accommodation

Clare County Council continue to progress our Traveller Accommodation Program [TAP] 2025 - 2029. We held our third LTACC meeting of 2025 on 24th September, 2025 and welcomed 2 new Traveller Representatives onto the Committee. Training for the LTACC is being scheduled for November 2025.

Approved Housing Bodies are providing approximately 1,010 tenancies to Social Housing Applicants. Clare County Council have full nomination rights in respect of the majority of AHB properties, except where they provide a portion of the capital funding from their own resources. These properties are advertised via our Choice Based Letting System. Nominations are prepared in accordance with a new National Process agreed by LAs and the AHB sector and commenced in July 2022.

Private Rented inspections:




Housing Grants:

Local Authority Home Loan

Local Authority Purchase and Renovation Loan

The Local Authority Purchase and Renovation Loan was introduced on the 22 July 2024. This is a government backed mortgage and loan for the purchase and renovation of derelict and non-habitable homes. The property must be eligible for the Vacant Property Refurbishment Grant, whether derelict, non-habitable or simply vacant.

The Homeless Action Team

The number of presentations to the Homeless Action Team including complex cases continue to rise. This continues to place immense pressure on the Homeless Action Team on a monthly basis.

Prevention and support remain a key factor in the workings of the Homeless Action Team. Several single and family household presentations worked with staff around prevention options and supports, which in turn averted the need for emergency accommodation and avoided entering homeless services. HAP services have increased this quarter with a small increase in those accessing and availing of HAP supports. Other individuals and families were supported in accessing emergency accommodation either within our services or through private establishments.

The Homeless Action Team continues to pursue additional emergency accommodation options at a time when accommodation is in high demand generally.

Homeless Services [Homeless Action Team HAT]

Clare Homeless Action team continues to engage with all necessary stakeholders, service providers and local supports to adopt a collaborative approach to the tackling of Homelessness.

Affordable Housing Schemes for County Clare

CCC continues to run Expression of Interest (EOI) Campaigns seeking proposals on options to deliver affordable homes in County Clare. CCC are also engaged with developers with potential for Part V affordable delivery.

To date, CCC have received approvals for access to the Affordable Housing Fund for the following developments:

- Tulla Rd Ennis 10 units (with Developer).
- Lahinch Rd Ennis 6 units (units allocated and at acquisition stage).
- **Shannon** 10 units (All units allocated and at acquisition stage).

CCC are currently engaged with other developers, that have expressed interest in affordable housing, for potential inclusion on the scheme. CCC are currently awaiting receipt of stage 2 applications from 3 no potential developments in Tulla, Shannon and Ennis.

There is an online information portal at https://affordablehomes. ie/ providing general information to the public with regards to affordable housing.

Serviced Sites for New Homes – Croí Cónaithe (Towns) Fund.

The Governments current "Housing For All" plan provides for Local Authorities to make serviced sites available for sale to eligible purchasers through the Croí Cónaithe (Towns) Fund. The sites in towns and villages across the country will be made available at discounted rates for qualified individual purchasers who wish to build their own home.

It is CCC intent to provide for Croi Cónaithe sites in Lisdoonvarna and Feakle with progress to date being as follows:

- **Lisdoonvarna** Design team appointed. Surveys complete, design complete & developing planning application.
- Feakle Need assessment complete. Surveys complete & procuring design team.


Defective Concrete Blocks Grant Scheme

The Enhanced Defective Concrete Blocks Scheme went live in mid-July 2023, for private dwellings, with the finalised Act, regulations, updated YQA's (Your Questions Answered) &

Ministerial Guidelines published.

On the 7th of November 2024, The Minister approved an increase in the grant cap from €420,000 to €462,000.

Homeowners can submit applications to the Defective Concrete Block (DCB) Scheme online via the Clare County Council (CCC) website. The site provides comprehensive guidance and resources to assist applicants throughout the process. A step-by-step instructional video titled "How to Make an Application" is also available to further support homeowners.



CCC continue to administer and validate applications received through the online portal. CCC maintains active engagement with both the Housing Agency and the Department of Housing, Local Government and Heritage (DHLGH), fulfilling all associated responsibilities.

To date, CCC have issued 61 Remedial Option Grants, with a total value of €19.5 million approx. An additional 100 applications are currently pending further input from the Housing Agency, with grant determinations to follow. There are a further 46 applications at draft stage on the online portal.

The National Standards Authority of Ireland (NSAI) is conducting a review of the current I.S.465 standard concerning deleterious materials, on behalf of the DHLGH. The public consultation period has concluded, and the NSAI are now reviewing the submissions received.

CCC carried out information evenings in Q2 in Ennis & Shannon. The focus of these evenings was orientated towards applicants who have received their grant option. These events were attended to capacity with positive feedback from attendees. CCC intend to hold further information evenings and walk in clinics in various locations in Q4 of 2025, to target people with limited digital resources and/or capabilities, to assist them further in making an application and other elements of the DCB application process. Clare County Council continue to engage with the DHLGH to ensure social houses affected by DCB are included in a similar scheme.

Update on capital programme:

Clare County Council's direct build projects that are currently under construction include the Back Road development in Kilrush, the Doonbeg development, the Gort Road, Ennis development, the Shallee Drive/Cloughleigh Road development in Ennis and the Moore Street, Kilrush development. These projects are all progressing well. Other housing capital schemes are at varying stages of design.

Energy Efficiency Retrofitting Programme

The Clare Climate Action Plan 2024 - 2029 sets out overall targets for Clare County Council:

- 51% reduction in Clare County Council's own emissions
- 50% energy efficiency increase by 2030

A key requirement of the Plan was the identification of a Decarbonisation Zone (DZ) and the Kilkee/Loop Head Peninsula has been designated as the Decarbonisation Zone (DZ) for Clare County Council.

A key objective of the Plan is the retrofitting of the Social Housing Stock across the DZ, which currently number 136 units. The Housing Section are liaising with the Department of Housing, Local Government and Heritage and will prepare a Business Case to seek funding under a phased basis over the lifetime of the Plan for the retrofitting of these houses.



LOCAL AUTHORITY INTEGRATION TEAM

Recent CSO figures show there were 746 Temporary Protections granted nationally in the past month with an average of 24 granted per day. There are currently 4,388 Ukrainian Beneficiaries of Temporary Protection (BOTP's) living in County Clare, representing a decrease of 664 people in the County compared to figures released previously. There are 993 people accommodated in 19 multi-occupancy facilities located throughout the County - this reflects a decrease of 80 people compared to previous figures. The remaining people are accommodated in residential settings, in formal hosted arrangements, through the Irish Red Cross and Clare County Council's Offer-a-Home scheme. To date our Matching & Relationship Manager has facilitated the accommodation of 465 people that were originally living in hotel and multi-occupancy facilities.

The Government has announced changes to access and absence arrangements for State-contracted commercial accommodation effective from 8th September 2025;

The changes relate to accessing accommodation for people who arrived in Ireland before March 2024, and who are not already in State-contracted accommodation. This means that people who may have been State-contracted accommodation but have since left either through the ARP programme or private rented cannot avail of a second offer of State-contracted commercial accommodation. This also applies to people who arrived in Ireland before March 2024 and who may not have availed of State-contacted commercial accommodation to date.

This does not impact people who are currently in Statecontracted commercial accommodation, if they remain in it. It does not affect people who arrived after March 2024, for whom accommodation is provided for a period of 90 days.

People can continue to access Government supported accommodation under the Accommodation Recognition Payment scheme (ARP).

People in vulnerable circumstances may attend the Citywest Transit Hub seeking emergency accommodation and will be assessed on a case-by-case basis.

Changes relating to absences from accommodation for people living in State-contracted commercial accommodation can now be absent from their accommodation for a total 3 absences, totalling no more than 21 days per calendar year. Absences must be arranged in advance and retrospective absence claims cannot be processed.

Local Authority Integration Team



The Local Authority Integration Teams (LAITs) have been set up in all local authorities. Their purpose is to help coordinate the different kinds of support available for people who are applying for international protection, refugees, and others in similar situations.

The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important

services that can help them integrate into the community.

Who do LAITs support?

LAITs provide support for:

- Applicants for International Protection (IP)
- People who have been granted refugee status or other forms of protection, such as subsidiary protection or permission to remain
- Refugees who have been resettled in Ireland through a government programme
- · Beneficiaries of Temporary Protection (BOTPs)

How is the support provided?

LAITs operate under the principle of 'Integration from Day One'. This means that LAITs provide integration support to people who need it as soon as they arrive in Ireland.

What services do LAITs provide?

The work of LAITs isn't meant to replace existing services. Instead, LAITs help connect people with the existing services that are most suitable for their needs. This includes things like:

- Being a direct contact for new arrivals, helping them with any problems they might have when dealing with public services
- Connecting new arrivals with services like legal help, childcare and healthcare
- Connecting new arrivals with services that improve their ability to live independently, like job training, English classes, education, and apprenticeships
- Guiding new arrivals through the process of applying for financial support, medical help, child benefits, and other services they might need
- Holding meetings in local areas and using community development principles to help those who attend
- Supporting people if they face racism or other unfair treatment, helping them report it to the right authorities
- Helping vulnerable new arrivals get in touch with nongovernmental organisations (NGOs) and other services if they need extra help

The exhibition is currently on display in the De Valera Library until 3rd October, after which it will travel across the county, continuing to celebrate the Faces of our Community.














AkiDwa Migrant Womens Network

Clare County Council's Integration Team was delighted to collaborate with AkiDwA – the Migrant Women's Network in delivering a women's health support and information session in North and East Clare.



ing. Many children progress through each level of swimming lessons and qualify to join swim club run by Clare water safety.




Studio Hire

Each station encourages the use of reusable bottles and provides free clean water, reducing reliance on disposable plastic bottles in busy community hubs.

Eye-catching designs and clear labelling help the stations stand out in their respective locations. Anecdotal feedback from users in recreational and sports settings suggests strong community support for these amenities, particularly during large events and

peak park usage times. This installation is expected to deliver ongoing value for Ennis residents promoting good health practices through hydration. took place from August 10th to 17th, with over 133 women and teenage girls participating in 15 events across various locations in the county. To deliver this programme, Clare Sports Partnership partnered with a range of clubs and local providers. The activities offered something for everyone from water-based events such as sailing and kayaking, to lighter, social activities like yoga and a dip or guided hikes, and even opportunities to try something new, including clay pigeon shooting and cycling. While the activities varied, the central focus remained the same: encouraging women and girls to get active in the outdoors in a fun, supportive, and welcoming environment.



• HER Outdoors Week - Beginner Walk

As part of HER Outdoors Week, I led a beginner 5K walk at the 12 O'Clock Hills with 12 female participants. This initiative was well received, and monthly walks will now be organised across different locations in Clare as part of a new Monthly Walk Series.

• During the month of August, we also ran an action-packed outdoor adventure camp in partnership with Derg Isle Adventure Centre, Scariff, for teen girls aged between 13 and 17 years. Twelve girls took part in the week-long camp for 3 hours each day. Some of the activities included kayaking, SUPing, rock climbing, teambuilding, archery and physical challenges. The feedback from the programme was very positive, and many of the girls were eager to engage in some of the activities again.

The roller-skating programme concluded on August 6th.

Participants enjoyed the sessions and have collectively decided

to continue skating independently as part of a group, showing positive long-term engagement & sustainability.

• Basketball Scrimmage

A six-week social basketball scrimmage concluded on August 19th. This programme provided a fun and social opportunity for participants to play and stay active.

As part of HER Outdoors Week, a taster bootcamp was delivered to assess interest levels. Based on strong feedback, a four-week bootcamp is scheduled for September at Shannon AC.

Twinning



Nort-sur-Erdre and Basse-Goulaine

A group representing Sixmilebridge travelled to their twin town of Nort-sur-Erdre at the end of August. They were accompanied by Councillors John Crowe and Tony O Brien representing the Clare County Council Twinning Committee. The invitation to both Sixmilebridge and Clare County Council was from Mayor of Nort-sur-Erdre, Yves Dauvé to celebrate the 20th anniversary of the twinning arrangement with Sixmilebridge, and which also included a group from Piedrabuena in Spain who were also in attendance. A busy few days were had with a number of meetings held with local community groups and the local authorities. A meeting with the local educational board was held and a priority going forward will be the student exchange program for both communities.

Mayor Yves Dauvé in all his speeches during the visit referenced the strong links and the relationships which had been established between the communities of Nort-sur-Erdre and Sixmilebridge over the past 20 years. Mayor Dauvé also acknowledged the support and hospitality offered by Clare County Council tourism and twinning sector, and thanked the council for their continued support.

In addition to this exchange, Councillor Tony O'Brien also met with twinning representatives from the nearby Basse-Goulaine, who are twinned with Killaloe / Ballina as a measure of maintaining this other strong twinning relationship.



China's National Day Reception

Cathaoirleach of Clare County Council, Councillor Paul Murphy was in attendance at the Chinese Embassy upon invitation from Ambassador Zhao Xiyuan and Madame LI Yi to celebrate China's National Day and 80 years marking the foundation of the People's Republic of China. This engagement proved fruitful in the exchange of new ideas for the established twinning relationship between the Burren Geopark and Yunnan Province.

Inis Cealtra Visitor Experience Official Opening

The Inis Cealtra Visitor Experience was officially opened on Friday, September 19, 2025 by Minister of State for Fisheries and the Marine, Timmy Dooley TD.

Housed in the restored Rectory in Mountshannon, which was acquired by Clare County Council in 2021, the building serves as a centre for visitors to interpret Inis Cealtra (Holy Island), one of Ireland's most significant ecclesiastical heritage sites, and the history of the neighbouring communities.

The €5.3 million refurbishment project, funded by the Department of Rural and Community Development and the Gaeltacht, with matched funding from Clare County Council, followed extensive consultation with elected members, state agencies and the local community.

The centre offers interactive exhibits on the island's history, community stories, immersive footage of Inis Cealtra, and a scale 3D model, providing an insight into the history of the island. The attraction also features a first-floor café and accommodates a ground floor external seated terrace within the landscaped gardens of the Rectory.

The official opening also marked the completion of public realm works in Mountshannon, a new shared surface on Main Street aimed at improving connectivity and creating a vibrant public space for the community and visitors.

Family Fun - Killaloe Bridge 7th September

Schedule of Municipal District Works 2025

West Clare MD is approaching completion of the 2025 Road Works Programme. Surface overlay contracts remain outstanding, but remain on course to deliver a muchincreased RWP in 2025 (an increased RWP budget of c. €2.3 million in 2025, an increase of c. 40% over 2024 RWP).

Repair of defect on N68 @ Tullagower

West Clare MD ran a Tender & appointed a contractor (Breedon's / Lagan) to repair a defect on the N68 Kilrush to Ennis Road at Tullagower. Approx 200 linear metres of the N68 has been upgraded.



Kilrush Bring Bank facility

West Clare MD, in conjunction with our colleagues in the Environment Section and Kilrush Tidy Towns recently upgraded the Bring Bank facility located in Parc de Plouzané, Kilrush. The wall was painted, new signage installed and some additional fencing erected.







Electric pick-up trucks

West Clare MD, in conjunction with our colleagues in the Roads & Transportation Section, recently replaced our two aged, diesel, half-moon litterbin & street sweepings collection pick-up trucks with brand new, zero-emission electric pick-up trucks. These are much kinder to the environment.



Kilrush Dog-fouling Initiative

West Clare MD, in conjunction with our colleagues in the Environment Section facilitated community engagement days, in association with the Community Warden & Dog Warden for West Clare. Both Wardens spoke to members of the public about dog control, beach bye-laws and litter & waste initiatives. Free dog-poo bags were distributed to members of the public on the day. The Dog Warden also took the opportunity to check dog licences in the Kilrush area.

Dog-fouling awareness signage (including footpath stencilling) was erected in Cappa, Kilkee & Alyveroo.

A speaker – playing a looped message about dog-fouling - was erected near the Turret Lodge, Kilrush.

The wardens left a box of dog-poo bags in Kilkee Tourist Office for distribution, free-of-charge, to members of the public.

CONSERVATION AND BUILT HERITAGE

Built Heritage Investment Scheme (BHIS) 2026 and BHIS Historic Thatched Buildings Scheme

Minister for Housing, Local Government and Heritage, James Browne and Minister of State for Nature, Heritage and Biodiversity, Christopher O'Sullivan, announced on the 25th July 2025, the opening of applications for the Built Heritage Investment Scheme (BHIS) 2026, including a dedicated funding stream for historic thatched buildings. BHIS supports owners and custodians of historic buildings to maintain and conserve the important structures which form an essential part of Ireland's cultural landscape.

Grants applicants under the Built Heritage Investment Scheme

may receive a maximum grant of €50,000 under the scheme, which must represent no more than 80% of the project's total cost. Buildings/structures eligible for funding under the scheme include:

- Protected structures (i.e. those on the local authority's record of protected structures)
- Proposed protected structures (i.e. buildings the local authority has proposed to add to its list)
- Structures in Architectural Conservation Areas (ACAs are defined by the Local Authority)
- Vernacular buildings (max grant for these is €30,000).
- Historic Shopfronts

Under the BHIS Historic Thatched Buildings Scheme , the aim is to protect the heritage value of historic thatched roof buildings across Ireland, including dwellings and other structures. The maximum grant available is up to €20,000.

Section 57 Applications

Section 57 Declarations are issued to owners of buildings or structures that wish to conduct works to their structures. A Section 57 Declaration determines whether works would be considered exempt from planning. A Section 57 Declaration can also be used to clarify the curtilage of a protected structure, or what elements are to be protected. There is no fee for a Section 57 Declaration.

Clare Placenames Committee

The Clare Placenames Committee met again in September and approved on the names of 3 housing estates in Corofin, Quin and Athlunkard. The committee has now met on 4 occasions in 2025 and decided on 12 placenames, mainly the naming of housing estates.

Clare Heritage and Biodiversity Forum

Clare Heritage and Biodiversity Forum held a meeting where Dave Pollack, archaeologist pre-sented the findings of the detailed survey of the partial mud house at Johnny Macks Cross in Tullaroe, Ouerrin.

TY Tasters in Traditional Skills

The Heritage Officer and Craggaunowen Castle and Crannog are offering an exciting opportuni-ty of a free skills training programme to Transition Year students in secondary Schools through-out County Clare. The course is designed to give TY students practical, hands-on experience in areas such as:

The programme is funded by the Heritage Council and Clare County Council and free of charge to the participating schools. We believe this programme offers students a valuable opportunity to develop practical skills in a unique cultural setting while enhancing their educational experi-ence and future employability.

The 2025 National Heritage Week Awards

The 2025 National Heritage Week Awards recognise the work of Heritage Week event organis-ers in creating and running events that highlight our built, natural and cultural heritage that took place all over Ireland for National Heritage Week. In 2025, over 100 events took place in Clare, where event organisers from across Clare brought their passion and expertise to create memorable and inspiring heritage experiences. These events highlight a shared commitment to preserving and celebrating Clare's heritage.

The Heritage Council announced the shortlisted events across several award categories, each representing an outstanding contribution to Ireland's heritage.

Kilkee Currach Presentation and Regatta undertaken by the West

Clare Currach Club were shortlisted for the national award under Intangible Cultural Heritage Award- The Mícheál Ó Muircheartaigh Award. The Intangible Cultural Heritage Award is awarded to an event or pro-ject that encouraged a greater appreciation of an element of our intangible cultural heritage, crafts, skills, customs and practices.



County Clare research on natural history showcased in The Dead Zoo Lab

A fascinating body of research by iCAN groups in Clarecastle and Ballyea Heritage and Wildlife Group and Kilkeedy Heritage Group, was unveiled the National Museum of Ireland, Collins Bar-racks. The aim of the Our Irish Natural History project is to highlight the role of communities as valuable stewards of Ireland's natural heritage and to celebrate the important cultural mean-ings that native species embody for many Irish communities. The research is now on display in The Dead Zoo Lab, an exciting new space for natural history at Collins Barracks while the fa-mous 'Dead Zoo' on Merrion Street is closed for works.

The research on Irish plants, animals and geological features was carried out by members of the Irish Community Archive Network (iCAN), an initiative of the National Museum delivered in partnership with The Heritage Council and Heritage Officers in participating local authorities.

Edenvale Lesser Horseshoe Bats featuring 5 caves in the locality and the 12,500-year-old Brown Bear patella that was found in the Edenvale Caves are beautifully displayed in glass cabinets. In between the two cabinets is a touchscreen facility displaying the research and linking back to the Clare iCAN website clareheritage. org

Kilkeedy Heritage Group in County Clare examined the recent rediscovery of a native popula-tion of Burren pine (Pinus sylvestris), Ireland's only native conifer species and the rare glimpse this offers into Ireland's ancient woodland past.

Members of the Clare iCAN groups were at the National Museum to unveil the new display of specimens, stories, visual art, videos and more. Our Irish Natural History is on display now at The Dead Zoo Lab at Collins Barracks, See museum.ie for further details.

BIODIVERSITY

Community Foundation Ireland Biodiversity Fund 2024

The Community Foundation Ireland Biodiversity Fund is now open for applications and closes at 4pm on Friday 17th October 2025. Clare County Council's Biodiversity Officer has been linking in with communities to apply for funding to prepare a Community Biodiversity Action Plan or implement biodiversity actions for existing Community Biodiversity Action Plans in towns and villages across the county. Clare has one of the highest number of Community Biodiversity Action Plans which are available to view at https://actionforbiodiversity.ie/counties/clare/. There are three levels of funding which amount to €6,000, €8,000 and €11,000 respectively where communities can work with a professional ecologist to develop and implement actions. East Clare Forest Schools Programme

In September and October 2025, Clare County Council's Biodiversity Officer supported and funded the forest school's educational initiative 'Wild Plants can Sing Forest School' which links local primary schools in East Clare to learn about native woodlands in their local area through biodiversity workshops. Primary school children from Flagmount, Dromindoora and Feakle national schools participated

in the 'Wild Plants Can Sing Forest School' initiative led by Heritage in Schools specialist Marina Levitina. The workshop introduces children to learn about ancient oak trees, native plants and where these seeds are sourced from their local area. This is the second year the initiative is funded by Clare County Council and promotes biodiversity education through creative learning.

Media Coverage

Clare County Council's Biodiversity Officer Barry O'Loughlin participated in two radio pieces in recent months to promote the Council's work with local communities and biodiversity actions. The first was Irelands top nature podcast series 'In Your Nature' hosted by Ricky Whelan and Niall Hatch. This podcast focused on biodiversity actions undertaken at Doonbeg Church Grounds which featured community members Jennie Drysdale and Ann McLaughlan of Doonbeg Tidy Towns. The second radio piece was Clare FM's 'Beyond Belief' hosted by Stephen Fletcher. This radio piece featured the Biodiversity Officer and community member Linda Hebenstreit of Christ Church (Church of Ireland) Spanish Point and the biodiversity actions undertaken there such as wildflower meadows, installation of barn owl nest boxes, bat roost boxes, bird tables and undertaking training events around wildflower identification.

Barn owl Nest Box Installation

Clare County Council's Biodiversity Officer and Birdwatch Ireland's Alan McCarthy installed barn owl boxes throughout the month of September at Kilkee, Tulla, Clooney Quin and Spanish Point. Barn Owl is a red-listed bird species of conservation concern due to declines in the breeding population. In July, measurements of owlets were undertaken including weight, wind span and chicks were ringed. The project is funded by Clare County Council and the Local Biodiversity Action Fund (NPWS).

Asian Hornet

The first-ever Asian hornet nest, an invasive species, was located and safely removed from Cork city in early September 2025, marking Ireland's first confirmed instance of a nest colony. A multiagency group, including the National Parks and Wildlife Service and National Biodiversity Data Centre, is leading efforts to prevent its establishment, as it poses a severe threat to native pollinators including solitary bees, honeybees and bumblebees. Clare County Council through its social media channels has raised awareness of this issue and for the public to remain vigilant and report any suspected sightings with a photo via the National Biodiversity Data Centre (NBDC) reporting portal. There are no confirmed sightings of the species within Clare at the present time.

Strategic Integrated Framework Plan (SIFP) for the Shannon Estuary

Clare County Council Planning Department are preparing a submission in response to the Public Consultation on National Territory Mapping for Renewable Electricity - Article 15b of <u>EU Renewable</u> Energy Directive (2023/2413).

The Public Consultation will seek input from the public on the


following:

- the national territory mapping that has been undertaken (under Article 15b); and on
- any key considerations that should be taken into account, in preparing a draft plan(s) for the designation of at least one Renewable Acceleration Area (under Article 15c).

The purpose of this Consultation is to take into account the views of the public, on the inclusion of areas already designated for renewable energy generation, in existing City / County Development Plans, for the purposes of the mapping exercise required under Article 15b of REDIII. It does not alter or amend any existing plans, nor does it affect their status under any enactment. The purpose of the Public Consultation is also to invite any key considerations from the public, in preparing a draft plan for the designation of at least one Renewable Acceleration Area (under Article 15c), noting that any RAA must be a "sub-set" of the areas identified in the "national territory mapping" exercise. For example, such key considerations could include any environmental issues or sensitivity criteria. that should be taken into account in the designation of an RAA.

The Planning Department have provided all available GIS information with regards to our Grid-Scale Onshore Wind in terms of our designations as outlined in the counties Wind Energy Strategy which forms a separate volume of the Clare County Development Plan 2023-2029. Local authorities are obliged by Department of Environment, Community and Local Government Circular PL20-13, to delay the reviewing of their Wind Energy Strategies until such time as the new national-level guidelines are available to Councils This non-statutory public consultation exercise will form one element of the preparation of a draft plan for the designation of an RAA and the establishment of appropriate rules on effective environmental mitigation measures.

Clare County Council as lead authority on the SIFP Steering Group will be advocating for the Shannon Estuary with its deep-water ports, access to unparalleled hinterland and availability of Grid Connection to be identified as a Renewable Acceleration Area. - Mentoring: LEO Clare has had a substantial demand for oneto-one mentoring support. To date, 316 clients have been assigned expert mentors to assist them in enhancing their businesses, 26 of those assigned during the month of September.
- Training: Approx. 150 participants took part in a range of training programmes over the month of September, in the areas of Start Your Own Business, Bookkeeping, Social Media & Artificial Intelligence training.
- Productivity Supports: With rising prices affecting all businesses, LEO Clare has various productivity supports to assist businesses offset higher input costs. To date in September, LEO Clare have processed applications for 27 Digital for Business, 23 Green for Business and 13 Lean for Business consultancies, along with 18 Energy Efficiency Grants and 7 Grow Digital Vouchers.

Property Transactions and Conveyancing

The property market in the County continues to be quite active, albeit that there is a shortage of supply, particularly in the residential sector. The Property Management unit continues to assist many solicitors acting for their clients on issues associated with title, boundaries, old leasehold folios etc. We are also processing a number of applications for first registration of Council property to ensure they are properly registered with Tailte Éireann.

Property Capital Projects

There are a number of capital projects at planning stage or at construction stage:

• Tullyvarraga Community Hall upgrade

The Property Team is working with the Committee for the Hall and

the Shannon Municipal District Team to assess the upgrade and re-habilitation works needed to address continuing defects in the building. This will also give an opportunity to see how the building can be improved to meet the needs of the community.

Bellevuve House, Harmony Row, Ennis

Works are well underway on the upgrading of this property, which is a protected structure. The works include an upgrade of Mechanical and Electrical services, which has not been done in 30 years. This project will also provide energy efficient measures, meeting room space, canteen and improved office space.

Casual Trading

This has been a busy Summer season for Casual Trading activity with many events and festivals being held in the Summer months. Five licences were issued in the last month, including licences for traders at the successful Shannon MELA event. There are challenges to be met to ensure all traders are managed, do not create disruption or waste management issues when operational and this is a key focus of the team for this year. In addition, there are a number of unauthorized traders setting up around the County without licences and we have to be vigilant in ensuring they do not continue to operate without a licence in a public place.

DERELICT SITES

A significant push to transform the many derelict properties across the County is underway with 285 derelict properties being dealt with under the Derelict Sites Act 1990 as of the 29th September 2025. The team maintains very high levels of activity and engagement with owners and their legal/technical representatives. This initial engagement is key to resolution of the issues of dereliction and to gain an understanding of the various reasons why the properties are in a derelict state. Where derelict properties are sold by the owner, the Derelict Sites Team is quick to brief the new owners on their responsibilities under the Derelict Sites Act, 1990.

To bolster the momentum, the Council is advising property owners

on accessing the vacant property refurbishment grant. The Team is also seeing a consistent number of planning applications for property refurbishment/extensions, and it is clear from driving around the county the level of work ongoing on individual properties. The Derelict Sites Team believe that by working in partnership with owners and financial institutions, there are real opportunities for the positive revitalisation and re-development of many properties.

Compulsory Acquisition of Derelict Sites (CPO)

The Department of Housing, Heritage and Local Government is promoting a CPO activation programme for local authorities, with targets for the number of CPOs to be done by each local authority. The Table below sets out the status of CPOs commenced by the Derelict Sites Team in Clare County Council since 2022 to the

current year. It is important to note that the CPO process can be lengthy and complex.

In addition, the Urban Regeneration and Development Fund will provide a revolving fund for CPOs of properties in the town of Ennis with the objective being that they would then be sold on the open market. We work closely with the Department of Housing, Local Government and Heritage and the particular emphasis is on properties that have potential for residential use. Two such CPOs are with the PRA for registration. Actions taken on properties in the town of Ennis has resulted in a number of properties coming to market or making plans for site development.

Derelict Site Levy

Determination of valuations on properties on the Derelict Sites Register is ongoing and notices of valuation have issued to properties as detailed in the table below. Four owners had appealed the valuation to the Valuation Tribunal and the following decisions have been made i.e. one appeal was rejected, one withdrawn, one settled and one is outstanding. The levy is an annual levy while the property remains on the Derelict Sites Register and amounts to 7% of the value of the property, on an annual basis. Assessment of valuations and billing of the levy will be further progressed during 2025 and it is intended that all properties on the Derelict Sites Register will be valued for the purposes of billing the levy. This levy will go towards the cost of billing and collection of the levy and resourcing of derelict sites function, up to and including CPO of properties.

VACANT PROPERTY REFURBISHMENT GRANTFOR DERELICT AND VACANT PROPERTIES

As of the 23rd September 2025, the value of grants approved by Clare County Council under the Vacant Property Refurbishment Grant Scheme is almost €27 million (448 grant applications approved or 67% of all applications), with further approvals due to issue.

This is a very significant investment in housing in County Clare and the work ongoing around the county on renovations and extensions is very visible. The Vacant Homes Team continues to advise applicants by phone and in person on all elements of the scheme and is available to meet with individuals (by appointment) to take them through the process.

The Grant is making a real difference in boosting the supply of rental properties and properties for permanent residence and will deliver on a key priority of 'Housing for All' National Policy and the Vacant Homes Action Plan, the key objective of which is to reduce vacancy and dereliction in our cities, towns, villages and rural countryside and provide more housing options in the process.

The breakdown of Grant approvals by Municipal District is shown in the Table below.

We continue to have high levels of enquiries and applications for the Grants and the total applications since the scheme was introduced in July 2022 is 661, with 164 received in 2025 to date. We are in the top seven local authorities in the Country in relation to application numbers. Our response time for initial assessment of new applications is generally three to four weeks.

Many others are in the process of submitting their claims for payment. Once the final site inspections take place, all the financial and legal elements of the grant are completed. The level of claims for payment is increasing every day and the Team work closely with owners on this process.

Other Points of Information

- The breakdown of applications between urban and rural areas has remained consistent - 56% of applications are for rural areas of the county and 44% for properties in towns and villages.
- 2. To date, 70% of applications are for properties to be used as principal private residence (456 properties) and the balance of 30% are for rent.
- Approximately 58 property owners have applied to have the period to complete the works extended. Such requests are considered on a case by case basis, depending on the level of work carried out to date and the timeframe needed to complete the works.

Following the summer works programme, September was again extremely busy with many projects and schemes progressing

during the month throughout the Town and Environs. Also during the month, Executive Engineer Kevin Carroll, a valuable member of the Team left us to take up a new position in his native County. All in Ennis MD wish Kevin well and thank him for his service.

Some of the main items carried out since the last Monthly Report are detailed below.

Urbact E-Connecting

As advised previously, Ennis is the Irish Partner in the above EU Project and during the month, representatives from Ennis MD joined other European Partners at the final Urbact E-Connecting transnational meeting in Faenza, Italy. The E-Connecting project which began in September 2023 is due to finish at the end of 2025. This meeting was an opportunity for all the partners to present their own journey in the development of the 'Integrated Action Plan' for their area. This collaborative EU project proved to be a very valuable knowledge sharing experience for all. Mayor of

Ennis MD, Cllr. Mary Howard and A/SEE Paddy Tiernan presented Ennis MD's integrated action plan to the Urbact Secretariat, Lead Partner and Lead Expert. The experience of going through the Urbact methodology will strengthen any future EU funding applications





Co-Creating Works

Ennis MD crews continued to work on the Co-Creating project throughout September. This project involves the tightening of junctions and the installation of raised pedestrian crossings throughout key locations in the town to improve accessibility and pedestrian safety. To date, over 20 junctions in Ennis have been upgraded under this scheme. The latest improvements carried out during September include four junctions along Lifford Road.



Quin Road - Road Works

During the past month, Ennis MD crews carried out road strengthening and stablishing work on the R469 Quin Rd at two locations in the townland of Ballaghboy. This work is in response to the structural failure of the westbound carriageway. Several new drainage outlets were also installed as part of the project. The works were programmed to be completed in time for the upcoming re-surfacing of the Quin Road.



Road Strengthening and Stabilisation at Kilfeilim

Also during the month, Ennis MD carried out road repairs and road stabilisation works on the L-8168 within the townland of Kilfeilim. This important local road provides access to several residential properties as well as access to a commercial business which generates a significant amount of HGV movements. Over time, these movements had resulted in the road deteriorating

significantly with a consequential risk of collapse. Ennis MDs timely intervention has eliminated this risk and strengthened the road for use over the years ahead.



Low Cost Safety Scheme - Clarecastle

Ennis MD staff commenced work on a Low Cost Safety Scheme in Clarecastle during September. The project involves new raised pedestrian crossings on Patrick Street and the tightening of the Lissane Road junction. The project also includes upgrades and extensions to footpaths, the installation of drainage and the installation of new signage. The project, when complete, will increase the safety of all road users in the area.



Low Cost Safety Scheme - Barefield

Similarly, the Low-cost safety project planned for Barefield village has commenced. The project will extend the existing footpath on the Ruan Road to the junction of the R458. The scheme also includes traffic calming, pedestrian crossings, and additional street lighting at the junction with the R458 Ennis to Gort Road resulting in the increased safety of all road users in the area.



Barrack Street

Ennis MD organised for the trees to be cut back on Barrack Street, this is to facilitate the erection of the large parasol as part of the ongoing Public Realm works in the area which are nearing completion.



Traffic Light Upgrades Ennis

The existing pedestrian traffic lights have been upgraded with a new ELV controller and new traffic light signal heads on Harmony Row in advance of the new school semester commencing. Civil works and installation were carried out by Ennis MD staff the Council Electricians. The works were completed in order to improve safety in the area that is used heavily by the public and school children enroute to and from the town centre.



Ennis MD Public Events

Ennis MD were delighted to facilitate, in collaboration with various stakeholders, a number of public events over the last month. Events including the Long Grazing Acre and Local Blacksmith events carried out over 2 consecutive weekends in the Market Building attracted large numbers. Ennis MD also worked closely with An Garda Siochana, Project Management Office in Clare County Council and Quare Clare in accommodating the Clare Pride March in Ennis which was followed by a number of family friendly events in Glor over the same weekend.









Ennis N.S Walking Bus

Following consultation with Ennis National School, Ennis MD carried out landscaping works along Cnoc na Scoile to accommodate the safe routes to school walking bus initiative undertaken by the school. Works included trimming of overgrowth, removal of weeds and grass cutting along the route.



Repair works at Garden of Remembrance

Following vandalism and damage to the limestone sculpture in the Children's Garden of Remembrance in Cloughleigh, a specialist contractor was engaged to undertake repair works and restore the sculpture to its original state.



Key Strategic Projects

In addition to the above, Ennis MD staff continue to progress and assist on a number of other key projects within the District such as the Town Bus Project, the Area Based Transport Assessment (ABTA) relating to the DRAFT Local Transport Plan. We also continue to work on a cross-directorate basis with our colleagues, supported by the various Government Departments, in advancing a number of other works throughout the Town and Environs.

Other projects that Ennis MD staff are involved with include the Ennis Public Realm Project, the LIHAF Access Road project, the THRIVE project at the Cloister as well as the development of a carpark in conjunction with the GAA at the Cloister end of Cusack Park.

In addition, we also work closely with our DAC colleagues in developing the ambitious plans outlined in the *Ennis 2040 Economic & Spatial Strategy*. Of particular interest during the month was the completion of the purchase of the former Boys National School site on the Kilrush Road as well as an extremely useful meeting the Council held with Roche Senior Executives, both local and from their HQ in Switzerland, along with the IDA and Enterprise Ireland regarding progress on the remediation works occurring on the Clarecastle site presently and the next steps required in planning for the future opportunities the remediated site will present.





TRANSPORTATION

Roadworks Programme and Operations

The 2025 Roadworks Programme is progressing well in all 4 Municipal Districts.

Strategic Transportation

Active Travel

The following is a brief overview of the activities within the Active Travel Office:

Tulla Road Active Travel Scheme:

The construction tender for the Tulla Road Active Travel Scheme has been awarded to Neville Civil Works. Construction is expected to begin on site in the coming weeks and is scheduled to last for 12 - 15 months.

Limerick Road (incl. St. Flannans Drive) Cycle Scheme:

Final iterations of Preliminary Design drawings have been issued for approval to the NTA. It is anticipated that the scheme will go to non-statutory public consultation in the coming weeks.

Ardnacrusha to Athlunkard Bridge:

The NTA have reverted with comments and feedback on the Draft Option Selection Report that was previously submitted. Clare County Council is addressing these comments with a view to agreeing on a preferred option for final submission to progress to the Preliminary Design Phase.

Safe Routes / School program:

Gaelscoil Ennis:

Consultants have been appointed to investigate potential options for linking Corrrovorrin and Fioruisce residential areas.

It is also proposed to install a raised uncontrolled crossing between the school and the Gort Rd as part of the Safer Routes to School Scheme.

Holy Family National School Phase 2:

This scheme is complete, and the project launched on the 1st October.

Barefield National School

Works are underway which will provide safer connectivity between Barefield Village and Barefield National School.

The Bus Stop Enhancement Programme:

The NTA has established a Bus Stop Enhancement Programme for Local Authorities which will provides an allocation of €500,000 to each Local Authority to facilitate the enhancement / upgrade of existing bus stops to meet the Transport for Ireland minimum requirements for customer experience. Clare County Council is engaging with the NTA in relation to the upgrading of bus stops throughout the county.

Machinery Yard - Fleet Replacement Plan / Fleet Decarbonisation

The Machinery Yard took receipt of 6no Electric Pick-Ups and 2 no EV Vans to be distributed across the county to MD's and sections within the organisation. The vans became operational in late August and shall contribute towards the de-carbonisation of the CCC Fleet and work towards the Transport Actions within the Clare County Council Climate Action Plan.

Health and Safety

The Health and Safety team are continuing to carry out their work programme including the annual revision and updating of

ancillary safety statements, risk assessments, schedule of safety inspections, briefings with staff etc.

Following successful certification to ISO 45001:2018 in the Physical Directorate, Housing, and Fire & Rescue Services last year, an ISO 45001 surveillance audit will take place in December. The audit will be carried out by the NSAI, and the Health and Safety team are currently engaging with the relevant sections in relation to preparing for the audit.

A new Health and Safety Officer will be taking up their appointment on the 6th October, filling a vacancy within the Health and Safety team and organisation due to the previous officer transferring to Uisce Éireann.

CAPITAL DELIVERY / PROJECT MANAGEMENT OFFICE

Doolin Pier	The PMO is currently liaising with the department regarding future funding requirements to bring project to Planning stage. The MD is progressing construction of footpaths between Fisher Street and Doolin Pier, for which works are scheduled for resumption in coming months. Once complete, this will ensure that pedestrian connectivity between Fisher Street and Doolin Pier.
Ennis Public Realm Regeneration (Project B)	The project works are now significantly completed. 5 of 8 phases are now complete and 1 other phase (Barrack Square) is due to be re-opened to through traffic in early October. With the Cathedral area hand over, and in combination with works previously completed along O'Connell Street, there is now a continuous stretch of Shared Space Public Realm Streetscape fully open for the use and enjoyment by our traders and the public. The revised layout of O'Connell Square is clear to be seen, now that construction areas are giving way to newly finished sections of paving. The street planters now delineate the new central plaza area within the square and showcase the clean geometrical lines of the street fountain. The street fountain installation itself is well progressed, with interconnecting mechanical and electrical services in place, and paving being completed in preparation for commissioning. The contractor has recently mobilised to the areas south and east of the monument to progress construction of steps, thereby replacing existing railings and access, and resulting in a revised access and presentation of this side of O'Connell Square. Contract resources are now being concentrated at Bank Place and large areas of newly paved shared space and pavement have been completed in recent weeks. The works from Bank Place to the Post Office bridge will be the last work element to be completed and we look forward to restoring through traffic to this route at the earliest opportunity.

	Consultation with impacted traders and stakeholders is ongoing, and the contractor has appointed a Public Liaison Officer in this regard, in line with Works Requirements. Focused stakeholder consultation events were held on 9th December 2024, 19th March 2025, and 9th June 2025 to review upcoming works phases. The contractor is also issuing weekly newsletters to inform of upcoming works. (Subscribe to ennispublicrealmb@shareridge.ie). The contractor, project team, and Clare County Council Resident Engineering staff are available to help traders and the public with any concerns and to mitigate impacts from the works wherever possible. It continues to be necessary to close streets to allow these works to be completed safely, and the project team and contractor, together with Ennis MD are working hard to coordinate activities to keep traffic impacts to a minimum and ensure that Ennis is kept open for business throughout the remaining months of this project.
Ennistymon Inner Relief Road and Bridge Crossing (Blake's Corner)	Legal and stakeholder liaison is ongoing. We await the outcome of Judicial review preliminary proceedings.

Phase 5 (Enabling and Procurement) & Phase 6 (Construction) will progress thereafter subject to timely consents, no legal challenge, funding, etc. The construction contract is estimated to be in the region of 18 months in duration. On receipt of the third submission the consultant will assess all and issue their recommendation for CCC's review.
West Clare Railway Greenway (Section 1: Kilrush to Kilkee)	Clare County Council, in conjunction with ROD Consulting Engineers, has commenced drafting the Environmental Impact Assessment Report (EIAR) and the Natura Impact Statement (NIS). Finalisation of the general arrangement and land acquisition drawings is currently underway. Following these consultations, land valuations will be updated accordingly. Meanwhile, the tendering process for the Ground Investigation Works is ongoing, with the appointment of the successful contractor expected soon.

Operational Duties:

- Civil Defence provided medical cover at a number of events in September including charity Tractor Run (Newmarket On Fergus); Senior Club Football quarter-finals and semi-finals (Cusack Park); Senior Club Hurling quarter-finals and semi-finals (Cusack Park) and Scarriff Agri Show (Scarriff).
- Clare Civil Defence members were tasked by An Garda Síochána to assist with two missing person searches in September. On both occasions Civil Defence volunteers were able to locate the missing people with drone technology resulting in the safe return of both individuals. The Boat Team were also placed on standby by An Garda Síochána for a river rescue in Ennis.

Environmental Awareness

An Taisce Green School Seminars

On 18th September 2025, An Taisce hosted a series of online Green School seminars for schools across Clare. The event featured breakout rooms where An Taisce presented on environmental themes such as Litter and Waste, Water, Energy, Biodiversity as well as Global Citizenship themes. These seminars offered Green School Coordinators the chance to learn more about the environmental theme that their school is currently working on. Attendees also had the opportunity to meet with our Environmental Awareness Officer and learn about local supports and initiatives.

Access to Information on the Environment (AIE) Requests

To date, 20 AIE requests have been received. One of these has progressed to internal review and is currently under appeal to the Office of the Commissioner for Environmental Information (OCEI). Decision makers and support staff are currently receiving training to strengthen their knowledge of the AIE Regulations and their capacity to handle AIE requests.

Waste prevention at the Harvest Music Festival

Our Environmental Awareness Officer attended the launch of the reusable cup initiative at the Harvest Music Festival, which took place at the Ennis Showgrounds on Sunday, 28th September. This initiative was supported through our Building a Circular Community Grant Scheme. As part of the festival's green initiative visitors were encouraged to bring their own reusable cup or borrow one through a deposit-return scheme.

September awareness campaigns

Throughout September, we supported a variety of environmental campaigns across both print and social media platforms. These included raising awareness about invasive alien species,

promoting good agricultural practices, highlighting the My Waste My Club seminars, encouraging responsible dog ownership and mattress amnesty day.

Waste Enforcement

Commercial Food Waste Inspections

Clare County Council is conducting inspections of commercial premises to ensure compliance with waste segregation requirements, particularly the obligation to segregate food waste in accordance with S.I. No. 508 of 2009 - Waste Management (Food Waste) Regulations 2009, as amended.

18 commercial premises were inspected in September, and post-inspection letters have been issued. This is in line with our RMCEI planned inspections for 2025.

Anti-Dumping Initiative

Mattress Amnesty Day Central Waste Management Facility, Inagh

Clare County Council is conducting inspections of commercial premises to ensure compliance with waste segregation requirements, particularly the obligation to segregate food waste in accordance with S.I. No. 508 of 2009 - Waste Management (Food Waste) Regulations 2009, as amended.

18 commercial premises were inspected in September, and post-inspection letters have been issued. This is in line with our RMCEI planned inspections for 2025.

Dog Fouling Measures Employed

In response to the identification of areas as Dog Fouling blackspots, our Dog Warden focused on specific locations to show a presence in the area, to engage with dog owners and advise them of their responsibilities. Stencilling was provided on the footpaths and "Audio Warning Devices" (purchased under the Anti-Dumping Initiative) were moved to the problem areas, to give a warning message about dog fouling.

Waste Facility Permit (WFP) / Certificate of Registration (COR) Inspections

Inspections of 8 permitted and 1 unauthorised facility were carried out by the Waste Enforcement team in September. Follow-up enforcement action is ongoing in the case of the unpermitted site. The permitted sites were inspected to monitor compliance with their permit conditions, to achieve positive environmental outcomes. An Authorised Treatment Facility for end-of-life vehicles was also inspected for compliance with its permit.

Annual Return Validations and Inspections of WFP/

Validations of Annual Returns submitted by permit holders for 2024 continues throughout September as required by the Regional Waste Enforcement Lead Authority. This work involves site visits and liaison with site operators as well as desktop validation of data received.

Advertising Signage

Ongoing liaison with auctioneers regarding the placement of signage on public lands directing potential buyers to properties for sale, advising them of their responsibilities under Section 19 of the Litter Pollution Act, 1997 as amended.

Abandoned Vehicles

In line with Clare County Council's policy and Section 71 of the Waste Management Act, we continue to monitor and take enforcement action on vehicles which are abandoned in public places. This work is carried out in conjunction with the Municipal Districts and An Garda Síochána. 14 abandoned car complaints were dealt with in September, leading to 3 being seized and transported to a permitted site for temporary storage.


CLIMATE ACTION

SEAI Publish Emissions and Energy Target Progress for 2024


Clare County Council is subject to two emissions reduction targets, with the first to reduce emissions by 51% from transport and heating and the second to reduce emissions by 51% from transport, heating and electricity combined consumption. SEAI have finalised energy reporting for the year 2024 highlighting Clare County Councils progress towards these targets. In 2024 emissions from transport and heating were 17.2% below the baseline. To achieve our target we must reduce emissions by another 40.8% within the next 6 years. In 2024 emissions from transport, heating and electricity combined were 35.4% below

the baseline. To achieve our target we must reduce total emissions by another 53.3% within the next 6 years.

Clare County Council is actively using HVO, a sustainable zeroemission fuel, across our fleet and advancing the procurement of Electric Vehicles. We are also retrofitting large buildings swapping out fossil fuel heating systems for renewable sources such as heat pumps and biomass. We are also actively reducing our energy consumption through careful energy management, installation of energy efficient technologies such as LED lighting and generating our own renewable energy through the installation of Solar PV systems.

NZEB & Retrofit Mobile Training Unit Coming to Clare

Clare County Council, in collaboration with LOETB's Mount Lucas National Construction Training Centre, is bringing the NZEB & Retrofit Mobile Training Unit to Clare for the very first time from October 20th – 24th. This state-of-the-art mobile training unit, the only one of its kind in Ireland, offers a hands-on learning experience for those interested in construction, retrofit, and sustainable building practices, skills that are increasingly in demand as Ireland transitions towards a low-carbon future. We are working with local schools and community groups to participate in courses on board the rig throughout the week. We are also offering a limited number of places for staff of Clare County Council to participate in a Retrofit for Homeowners training session aboard the mobile unit while it is in Áras Contae an Chláir.



Energy Clinic Takes Place in Ennis Library

Clare County Council's Energy Officer, hosted a free Energy Clinic in Ennis Library as part of Sustainable Development Goals (SDG) Week 2025. Community members booked 20-minute one-to-one sessions to receive tailored advice on topics such as solar PV installation, home energy retrofits, understanding energy bills, and available grants. The clinic supported Sustainable Development Goals (SDG) Week 2025 and Clare's commitment to community climate action. Feedback was positive, with attendees appreciating the accessible, practical guidance provided to help improve energy efficiency and reduce household energy cost

National SDG Stakeholder Forum – September 2025



RURAL WATER PROGRAMME

The Clare Rural Water Programme Office continues to support group water schemes to ensure a robust and sustainable quality and quantity supply of water is available.

In July the Clare Rural Water Programme Office welcomed the Departments update in relation to the Ministers decision on group water scheme applications for funding for projects under the Multi-Annual Rural Water Programme 2024–2026. Clare County Council's Rural Water Department held a well-attended meeting on 15th September 2025 with Group Water Schemes (GWS) that received funding in the most recent announcement. The session was highly informative and aimed to support schemes in progressing to the next stage under Measure A6 – Taking-in-Charge of Group Water Schemes. Additional meetings with Group Schemes are being held as required.

Staff members from the Clare Rural Water office attended the annual National Federation Group Water Service Conference, held in the Clayton in Galway in September 2025. This was well attended by community leaders, volunteers, and water professionals from across the country. The Group Water Scheme Excellence Awards ceremony was one of the highlights of the annual Conference.

These awards shine a spotlight on the innovation, resilience and community spirit that define the vital group water sector. 35

flags were awarded across the four main categories which were presented by Christopher O Sullivan TD. Clare County Council would like to congratulate all winners of awards, especially the Clare Group Water Schemes Kilmaley - Inagh GWS and Dysart-Toonagh GWS.

Group Water Scheme Taking in Charge applications continue to be progressed by the Clare Rural Water Programme Office. We currently have one GWS taken in charge application submitted to Uisce Eireann for their take over consideration and we await their decision and will update the scheme on receipt of same.

The Clare Rural Water Programme Office is working with Group Water Schemes in assessing the need to carry out emergency works and applying to the Department for exceptional urgent capital works for once off funding as they arise.

Applications for Group Water Scheme annual subsidy which is available to fund operational costs of group water schemes providing water for domestic use continues to be processed by this office.

All applications under the 'Grant for Improvement Works to a Private Water Supply' under the Rural Water Programme continue to be processed by the Rural Water Programme Office, 57 applications have been received to date in 2025. Post works final inspections for 2024 works within the last 12 months are ongoing.

Applications under the Domestic Lead Remediation Grant Scheme continue to be processed by the Clare Rural Water Programme Office. The Domestic Lead Remediation Grant Scheme helps households with the costs of replacing lead piping or

related fittings located within the internal distribution system connected to a domestic water supply that serves a house. We are processing applications as we receive them.
