

**Minutes of Budget Meeting of the Killaloe Municipal District held on Monday, 24<sup>th</sup>  
October, 2016 at 2.30 p.m. in Conference Room 316, Áras Contae an Chláir, New Road,  
Ennis, Co. Clare.**

The Cathaoirleach, Cllr. Tony O'Brien chaired the meeting.

On behalf of the members, he welcomed Anne Haugh, Area Co-ordinator to her first meeting of Killaloe Municipal District. Anne thanked the members for the welcome and also looked forward to working in partnership with the members.

Kieran O'Donnell, Meetings Administrator, advised the members that the purpose of the meeting was to consider the General Municipal Allocation, which is the discretionary funding being made available to municipal district members in the draft budgetary plan. He explained that the Local Government Reform Act 2014 provides that the municipal district members shall by resolution adopt the draft budgetary plan and that the Chief Executive shall take account of any budgetary plan adopted by the municipal district members. He referred to the letter from the Chief Executive dated 7<sup>th</sup> October 2016 which had been circulated with the Agenda advising the members that the total proposed General Municipal Allocation (GMA) was €257,800. This represented an increase of €220,000 over the 2016 allocation, and the additional funding had been made available from the increase in Local Property Tax income.

Members welcomed the increase in funding that was being made available.

The following resolution was proposed by Cllr. J. Cooney and seconded by Cllr. M. Begley and adopted by the members:-
