1. Minutes of Meeting of West Clare Municipal District held on 21st January 2016

The Minutes were proposed by Cllr. Chambers & seconded by Cllr. Keating.

Cllr. Slattery looked for an update on when works would be carried out to the N67 at Rineen. C. Feeney indicated that works were likely to commence in April. T. Tiernan provided a brief update on storm damage works for private landowners on the Shannon Estuary & the Atlantic Coastline. J. Corry indicated that he was continuing to liaise with Human Resources regarding getting a full time Traffic Warden for Kilrush. It was agreed that the free 2 hour parking would remain in place until the May meeting of the MD & that an update would be provided on parking for the May meeting.

2. Minutes of Special Meeting of the West Clare Municipal District to consider distribution of GMA Allocation for 2016.

The Minutes were proposed by Cllr. Nagle & seconded by Cllr. Chambers.

3. Minutes of Special Meeting of the West Clare Municipal District to consider draft Parking & Harbour Bye Laws for Doolin Pier.

The Minutes were proposed by Cllr. Nagle & seconded by Cllr. Slattery.

4. Draft Schedule of Municipal District Works for 2016

T. Tiernan provided an update on the draft Schedule of Municipal District Works for 2016. He outlined that the funding provided and the proposed works only dealt with 4.9% of the road network which meant that these stretches of road were only being looked at every 20 years as opposed to every 10 years. In answer to a query on the flexibility of funding to deal with Motions raised by Cllrs etc T. Tiernan outlined that there might be a small element of discretion with regard to the Discretionary Grant allocation. T. Tiernan outlined that the €2.8 m allocated under Tranche 1 for flooding damage would deal with a separate programme of works . He also added when questioned that no funding allocation was being provided for the LIS scheme as part of the SMDW. The members acknowledged that national grants were decreasing each year & that it left the Council with a very difficult job in trying to maintain its road network. The Cathaoirleach indicated his disappointment with the level of funding being provided for the SMDW. The SMDW for the West Clare MD was proposed by Cllr. Nagle & seconded by Cllr. Keating. The Members thanked T. Tiernan.

5. Draft Clare County Council Local Economic and Community Plan 2016-2020 (previously circulated)

G. Dollard provided an update. He outlined that the Plan had been circulated previously. He also mentioned that the members would have recd a report from the Senior Planner which outlined the consistency of the Plan with the Co. Dev Plan. He added that the Plan needed to go before the MDs & that there was a statutory requirement that they would adopt a resolution about the consistency of the LECP with the Co. Dev Plan & that the actions in the Plan should be considered .He added that the overall plan would be coming back before the Full Council for adoption when the SPC & the LCDC had considered it. The statutory resolution regarding the consistency of the LECP with the Co. Dev Plan was proposed by Cllr. Nagle & seconded by Cllr. Keating.

6. Establishing of Town Teams – Discussion document

G. Dollard went through the discussion document that had been circulated. He added that the discussion document was going before the MDs for their consideration before going before the Full Council. He queried if the members saw a merit in establishing Town Teams & if so should you go with a Capital town or with identified REDS. The Cathaoirleach suggested that you would go with the REDS. G. Dollard also indicated that consideration would need to be given to how much it would cost & as to how it would be staffed etc. A lengthy discussion followed where concerns were raised as to how it would be staffed & resourced. It was recommended that it should go back to the CEDRA. The members thanked G. Dollard.

7. Notice of Motion submitted by Cllr. Hillery

"That Clare Co. Council would resolve the flooding of the Ennistymon to Corofin road near Rath Church"

This Motion was seconded by Cllr. Curtin.

Reply

The flooding issue that occurs on the L-1118 at Rath Church, Corofin appears to be caused during periods of prolonged intense rainfall which the area has endured both this

winter and during the winter of 2009. The rainfall for the period December 2015 has been estimated at twice the usual average for that month. The road and surrounding land is situated in a natural depression with no outfall pathway for surface water to discharge to. The drainage at this location relies on subterranean swallow holes which appear to be at capacity due to the prolonged rainfall. The water levels are being monitored and have dropped on occasion only to rise again following any significant period of rain.

Unfortunately there is no obvious cost effective solution to resolve the problem other than to wait for more favourable weather which will naturally alleviate the issue.

When the water levels recede we will inspect the swallow hole to determine if there are any blockages which may account for the slow dissipation rates.

Irish Water has approved a capital project to decommission the Rockmount water treatment plant currently supplying parts of Milltown and rural areas to the north of the town, and to supply water to these areas from the Old Doolough treatment plant which already supplies most of the town, Spanish Point, and the rural areas to the south.

Laying of new mains and installation of a pumping station, as elements of this project, are already in progress between the town and Rockmount itself. The project will also include upgrading of parts of the mains on the line from Old Doolough treatment plant to Milltown via Mullagh and the Crosses of Annagh.

Which parts of the Old Doolough to Milltown line will be upgraded, and the programme for doing so, will be determined by Irish Water.

The Road Design Office is fully supportive of this initiative and it would be a valuable addition to the leisure and tourist product in Kilrush.

The flooding issue that occurs on the L-1118 at Rath Church, Corofin appears to be caused during periods of prolonged intense rainfall which the area has endured both this winter and during the winter of 2009. The road and surrounding land is situated in a natural depression with no outfall pathway for surface water to discharge to. The drainage at this location relies on subterranean swallow holes which appear to be at capacity due to the prolonged rainfall. The water levels are being monitored and have dropped on occasion only to rise again following any significant period of rain.

Unfortunately there is no obvious cost effective solution to resolve the problem other than to wait for more favourable weather which will naturally alleviate the issue. When the water levels recede we will inspect the swallow hole to determine if there are any blockages which may account for the slow dissipation rates.

L-62642-Creevagh.

The L-62642 at Creevagh remains closed due to the severe damage /demolition of the bridge following storm Desmond in early December. We have progressed the design element of the new proposed structure but are currently awaiting a response to our Section 50 application under the Arterial Drainage Act from the Office of Public Works. Once consent is received from the OPW it is our intention to finalise the design and proceed to procurement and construction of a new replacement bridge.

R-460 - Carrowkeel

The intermittent flooding on the R460 / N85 at Carrowkeel is again a direct result of prolonged intense rainfall. The Inagh river reaches capacity or beyond capacity and floods during prolonged rainfall events which limits or prevents the stream ,feeding from the north at Carrowkeel bridge ,from discharging into the Inagh river. The confluence of both of these river courses causes the northern stream to back up and flood across the N85 and adjoining land.

Prior to the Local Government Reform Act 2014 the making of an order declaring a road to be a public road was a reserved function exercised by the full Council not an Electoral Area. I have searched the minutes of the full Council meetings from 1995 to the present day, 21 years, and could find no reference or resolution declaring the above road to be a public road. Therefore in the absence of such a resolution of the Council we are not in a position to declare the road a public road and take it in charge. I have no hesitation in searching the records again if a more precise date could be given of when the resolution may have been passed.

Reply

The Non National roads which were identified as being damaged by flooding or which would benefit from implementation of defence works in the event of future flood events are detailed in the table hereunder. The total estimated cost submitted to the Dept in respect of the West Clare MD was €972,500.

The total equivalent estimated cost submitted for the County was \in 3.3 million and the allocation confirmed for the county on February 19th was \in 2.8 million. Therefore, the works proposed as per the attached table will have to be cut back somewhat – when the situation is further assessed, it is likely that the allocation available to the West Clare MD will be between \in 800,000 and \in 850,000

Reply

The clean up of the car parks will commence after the high tides which are scheduled around the 10th of March. Given that more extensive damage occurred in Doolin as a result of the 2014 coastal storms than as a result of recent events, the coastline in the vicinity of the harbour was identified as one which needs strengthening and so, in 2015, the OPW confirmed it's approval to the Council to appoint consultants to carry out a Feasibility Study in this context. Clare County Council has appointed a Consultant JBA Consulting/Cronin Miller Consulting Engineers to carry out a coastal flooding and erosion risk management study for Doolin with particular focus on the protection of the car parks Piers and Beach area. The study is carried out in line with the scope and terms of reference for such studies published by the Office of Public Works. The feasibility study will examine all the existing information available, gather the additional information required, produce flood and erosion maps, propose mitigation measures and carry out an estimate of benefit and costs. The study will inform future coastal protection works at Doolin including works associated with the master plan. The study will be completed in May and will be submitted to the OPW for funding to advance to detailed design, planning and construction stages.

J. Corry updated the members that works would be commencing on Phase 2 of Kilrush Sports Complex later that week.

It was proposed that the next MD meeting would take place in Kilmihil on 6th May at 11am to accommodate the 4 TDs who it was agreed would be invited to attend.

Cllr. Lynch proposed that the next three MD meetings of the West Clare MD (May, July & Sept) would take place at 11am. This was unanimously agreed.

This then concluded the business of the meeting.
